CLIMATE WARS: THE UN IRON FIST & CLIMATE AGENDA By James Reed

'The United Nations may resort to military action against states that defy its mandates on global climate action, according to Ole Wæver, a prominent international relations professor at the University of Copenhagen. In an interview with *ABC News* in Australia, Professor Wæver cautions that what he sees as 'climate inaction' might draw the U.N. into considering other means to ensure its goals are met, even if that leads to global armed conflict. Professor Wæver says more resistance to change could potentially threaten democracy although the U.N. would counter that the end justified the means in much the same way countries like Greece had their debt crisis solutions forced on them by European Union bureaucrats in Brussels and Strasbourg.

'The United Nations Security Council could, in principle, tomorrow decide that climate change is a threat to international peace and security,' he says. 'And then it's within their competencies to decide 'and you are doing this, you are doing this, this is how we deal with it'. He believes classifying climate change as a security issue could leave the door open to more extreme policy responses.'

"As Paul Homewood pointed out last month, there has been no significant long-term decrease in rainfall or increase in temperatures in the affected regions. Yes, it has been dry in New South Wales (where most of the worst fires are), but there have been several years, especially pre-1960, when it was drier. The same applies to temperature. Yes, this has been a hot spring in New South Wales. But there have been times when it has been much hotter — making a nonsense of all stories in the Australian media about temperatures being the hottest ever: Neither is the monthly average of 38.0C a record high. The three years from 1899 to 1901 all saw average December mean maximum temperatures well above 38.0C. *(continued next page)*

Since the station moved to the airport in 1993, 38C has only been exceeded once until this year, that was in 2005, when it averaged 38.5C, still well below the December 1899 when the mean was 39.9C. So, to be clear, there is zero evidence of any change in climatic conditions that might have increased the likelihood or severity of these bush fires. This is not — repeat NOT — a man-made climate change story, and anyone who

claims otherwise is either a gullible idiot or a lying charlatan".

Thus, the culture of the new environmental religion, along with the perennial problem of feral crazies who like to see things light up, creates the perfect storm leading to the catastrophic fires we are living through and, as usual, the political system will conveniently blame climate change, while ignoring the real causes.

AUSTRALIA'S HOTTEST DAY ON RECORD 1828

It is a pity that our knowledge of History and Science is at such a low level in the community that we are being led to believe that we have a climate emergency and that CO2 is the villain!

Back before man-made climate change was frying Australia, when CO² was around 300ppm, the continent savoured an ideal pre-industrial climate... RIGHT? This is the kind of climate we are spending \$10bn per annum to get back to... Right again?

We are told today's climate has more records and more extremes than times gone by, but the few records we have from the early 1800s are eye-popping. Things were not just hotter, but so wildly hot it burst thermometers. The earliest temperature records we have show that Australia was a land of shocking heatwaves and droughts, except for when it was bitterly cold or raging in flood.

In other words, nothing has changed, except possibly things might not be quite so hot now! Silliggy (Lance Pidgeon) has been researching records from early explorers and from newspapers. What he's uncovered is fascinating! It's as if history is being erased!

For all that we hear about recent record-breaking climate extremes, records that are equally extreme, and sometimes even more so, are ignored. In January 1896 a savage blast "like a furnace" stretched across Australia from east to west and lasted for weeks.

The death toll reached 437 people in the eastern states. Newspaper reports showed that in Bourke the heat approached 120°F (48.9°C) on three days.

As reported at the time, the government felt the situation was so serious that to save lives and ease the suffering of its citizens they added cheaper train services. What I found most interesting about this was the skill, dedication and length of meteorological data taken in the 1800s. When our climate is "the most important moral challenge" why is there so little interest in our longest and oldest data?

Who knew that one of the most meticulous and detailed temperature records in the world from the 1800s comes from Adelaide, largely thanks to Sir Charles Todd. The West Terrace site in Adelaide was one of the best in the world at the time, and provides accurate historic temperatures from "Australia's first permanent weather bureau [http://www.rahs.org.au/history-resources/the-first-weather-bureau/] at Adelaide in 1856".

Rainfall records even appear to go as far back as 1839. Lance Pidgeon went delving into the National Archives and was surprised at what he found. The media are in overdrive, making out that "the extreme heat is the new normal" in Australia. You can't blame those high records on man-made global warming! ***

The asset can now be credited to the community and the ledger 'squared off' leaving no debts behind. If the community do not want the school, or the materials are not available, or the community do not know how to construct the school, then the money is not issued under any circumstance —this is how the finance system should work!

But there is another aspect of the Finance System which MUST be understood...the current providers of Finance lay claim to the school AFTER it is built and they add another cost to the construction called 'interest' and they want to be paid for the school which effectively costs the community more than double its original cost i.e. school built by the community and then the money lenders for creating the Finance.

There are many people suffering because of the drought and bush fires and they should not be penalized for a disaster not of their making. The Government, through its agent the Reserve Bank of Australia, can and should use the resources of the RBA to rebuild the devastated communities without undue delay. People opposed to this course of action should be required to place their opposing argument before the Australia people for adjudication but let the rebuilding begin!

CAPITALISM DOING IN JAPAN NOW By James Reed

We don't hear much about this, but Japan, with its low birth rate, is also being subjected to immigration, not for replacement, as in the West, but on economic grounds, for the capitalists to keep the profits up. It is causing untold problems in this still relatively homogeneous population:

"In recent years, an increasing number of foreigners have been finding jobs in Japan, and not just in humanities and international services roles like teaching and translation. As more non-Japanese workers start joining the general-purpose Japanese workforce, though, some of their Japanese bosses are struggling with the changes to the business landscape, as shown in a recent survey by Japanese employment agency Persol Group. In a survey of Japanese managers with foreign subordinates, 34.3 percent of the 872 respondents reported that they feel intense stress because of the challenges the situation presents. Moreover, 17.2 percent of the managers of foreign workers said that if they could, they would like to quit their jobs immediately. When asked just what sort of difficulties they were grappling with (and allowed multiple answers), the managers had a long list of problems, with the top five being:

1. Foreign workers are very self-assertive (46.1 percent)

2. They don't understand things that are considered common sense to Japanese people (41.6 percent)

3. They make aggressive demands for salary raises (40.7 percent)

4. They have a low level of loyalty towards the company/organization (40.1 percent)

5. It takes a long time to teach them how to do their jobs (40 percent)

In addition when asked about the skill level of their foreign subordinates, 30 percent of managers said they were insufficiently skilled, and only 39.6 percent found their skills to be satisfactory. Given the stigma that Japanese management philosophies have as rigid and outdated, it'd be pretty easy to dump all the responsibility for these problems on the managers themselves.

It is difficult, but Japan will have to get used to immigrants. China too should start to get ready to open its doors to millions of Africans now that there is such a warm economic relationship between Africa and China, (to be covered in another article at this site).

Welcome to our New Year. 2020 already shows the need for a step change in political action. The Christmas break should have us all well prepared and ready for this.

Victorian readers may be concerned to learn that Premier Andrews has committed to a Memorandum Of Understanding MOU with Communist China – China's Belt and Road Initiative.
