THE CROWD By Arnis Luks

This week being Easter week, draws me to the problems of "the crowd", the crowd who welcomed our Saviour with palms on the Sunday, but by the Friday, called for his crucifixion.

When discussing the crowd and Peter's frailty (by denying Christ) with friends, their view was that the crowd may have been different on the Sunday from the Friday. After reconsidering the denial by Peter, it became clear we all become part of the crowd when the circumstances are right. Peter's frailty now becomes our frailty. He only did what each of us would do given the same or similar circumstances.

https://www.youtube.com/watch?v=YWsU5rXDFVc **Rene Girard** highlights the inordinate pressure of the crowd and this great human frailty, that even Peter who was in the very presence of Jesus, failed in his response to 'the crowd'. Gustave Le Bon also wrote about this phenomena in his 1896 book, titled "The Crowd" - a study of the popular mind, available in our online library.

The mainstream media are effective in fear mongering, in that they use the phenomena of 'Peer Group Pressure' - (the bullying crowd and the individual's desire to be 'accepted') as their tools of trade. Two books about bullying immediately came to mind - "*Rules For Radicals*" and "*Antifa, The Anti-Fascist Handbook*". A presumption of both is that Bolshevik bullies (criminals) are more acceptable than Nazi bullies (criminals). KGB dissident Yuri Bezmenov referred to the Kremlin as assassins, the ultimate criminal bully.

The term "community organiser" has a specific meaning. It was coined by the radical Chicago activist Saul Alinsky, a Marxist who believed in capturing the culture as the most effective means of overturning western society. The way to do this, he said, was through "people's organisations" composed largely of discontented individuals, who believed society was fundamentally unjust, and, who would take their lead from trained community organisers. These organisers, taught Alinsky, should "rub raw the resentments of the people" and "agitate to the point of conflict" while pretending to be middle-class folk in suits. Based on the premise that the revolution would come not through institutions but through the masses, the organisers' role was to galvanise the mob to oppose every institution of the state. In his handbook of sedition, "Rules for Radicals", Alinsky describes Lucifer as "the very first radical".

Advertising is really no better than being bullied into "socially acceptable" products or fashionable services. The most dominant bully in the modern world is the TV, and all yield to this unhealthy influence, even from a very early age. Edward Bernays turned advertising (changing public opinion about products or things) into an art-form - a psychological weapon.

Peter's situation teaches us to stand apart, to resist the baying crowd. It's not easy. It is in this area of standing apart that provides the answers to our modern dilemma. It is almost impossible for an individual to stand apart in a totalitarian society. It is only in genuine freedom that you can exercise the right to choose or refuse one thing at a time, to select the out-working of your individuality.

In a Christian society, which we once were, the government's justification for existence was in providing an environment where the individual could exercise maximum freedoms in areas of moral responsibility.

Society only withstands calls for totalitarianism if there is a moral anchor opposing in a clear voice. With no moral anchor, the politician, the leader and the voter are free to do whatever they like. Moral boundaries requires a template of acceptable behaviour by us all. As we have been deliberately de-moralised, behaviour comes closer to *laissez-faire*. If the individual can get away with it why not the politician? If the politician can get away with it why not the leader? So the "Responsible Vote" now comes to the fore.

If we want to look at the direction in which genuine democracy might advance towards bringing to bear the actual will (not the fleeting and manipulated opinions and feelings) of the people upon their rulers, this has already been envisaged, in two stages: 1. Douglas Social Credit recognises a social perspective in all communities of individuals - people coming together. "The new legal powers sought by Scotland's devolved law-makers undermine ideas of justice in place for hundreds of years, according to the Scottish Criminal Bar Association. The new Coronavirus (Scotland) Bill grants sweeping powers to Nicola Sturgeon and the Scottish Parliament, and makes dramatic changes to the criminal justice system. Among a long list of changes, the Bill seeks to:

• Replace trial by jury with bench trials, presided over by a Judge or local Sheriff

• Remove the maximum time of 140 days an accused can await trial

• Relax hearsay evidence law, allowing judges to hear pre-recorded witness statements that are not open to cross-examination

The new rules, unlike similar Diplock rules used in Northern Ireland in 1970s, do not guarantee an automatic right of appeal. Ellume, who produced a flu test kit. In a statement on their website, SCBA President Ronnie Renucci QC wrote: The SCBA believes that these draconian measures seeking to bring about seismic changes to our system of justice are premature, disproportionate and illadvised. They are at best a knee-jerk reaction to an as yet unquantified problem instigated by panic or at worst, something far more sinister."

The Coronavirus has seeped into every corner of our society. The finance world has not escaped and huge value losses have been experienced. As far as Australia is concerned, some commentators are predicting an onslaught from overseas investors wishing to buy Australian assets at bargain prices.

To stave off such happenings the Treasurer, Mr Josh Frydenberg, has planned changes to the Foreign Investment Review Board. This is the Board which must approve certain foreign investment before it can proceed. There has been value thresholds below which the Board need not be involved. The new threshold will be zero dollars, according to the Treasurer. Unfortunately he added that the new threshold would be temporary; inferring a post COVID 19 would see a return to old thresholds. They varied, with leniency granted to Trade Agreement partners which had levels of \$1.192 billion for non-sensitive business and \$275m for sensitive businesses. Non-FTA partner countries had thresholds of \$275m for all business acquisitions and \$60m for agribusiness. All are now \$0.

The Treasurer can be congratulated for his current concern but it certainly does not contain enough 'teeth' to be effective. It is more than thresholds which need attention. It is the criteria upon which the Board assesses the proposal.

To consider whether a proposition is "in the interests of Australia" can be massaged to suit anything desired. Governments of all persuasions have always stated that we need foreign ownership for development and the Board could determine it to be a reason to tick the box. However practically all development has been completed in the agricultural sector many years ago. A question without wishing to pick any selected example, would be, how much new development has the Chinese investor carried out on Cubby Station?

Here is a chance to put an end to the great sell-off of Australia. Contact your MP and Senators - recognise the change proposed but demand it be made properly effective by putting an end to Foreign ownership of Australian property and other assets. We cannot own property in some other countries and we want the same rule here. - ND ***
