THOUGHT OF THE WEEK: A CRITICAL ANALYSIS OF THE AUSTRALIAN GOVERNMENT'S RATIONALE FOR ITS VACCINATION POLICY By JUDY WILYMAN MSc BSc Dip Ed Ph.D **Abstract**

Vaccination policies in Australia need to be scrutinised because the use of a medical intervention in the prevention of infectious disease has serious health and social implications. Deaths and illnesses to infectious diseases were significantly reduced due to environmental and lifestyle reforms prior to the widespread use of most vaccines in the mid-20th century. Mass vaccination campaigns were adopted after this time as the central management strategy for preventing infectious diseases, with many new vaccines being recommended in the National Immunisation Program (NIP).

The implementation of mass vaccination programs occurred simultaneously with the development of partnerships between academic institutions and industry. The Australian government's NIP, like all member countries of the World Health Organisation (WHO), is recommended by the Global Alliance for Vaccines and Immunisation (GAVI). This is a partnership with the WHO and UNICEF that includes the World Bank, the International Monetary Fund, the International Federation of Pharmaceutical Manufacturers and Associations (IFPMA), the Bill and Melinda Gates Foundation (BMGF), the Rockefeller Foundation, the United Nations Development Fund (UNDF) and other private research institutions.

All members of this public-private partnership influence the development of WHO global health policies.

It is important that independent research is carried out to assess whether all the vaccines being recommended today are safe, effective and necessary for the protection of the community. It is also important to have comprehensive evidence that it is safe to combine multiple vaccines in the developing bodies of infants.

The framework for "undone science" is used to analyse the Australian government's claim that the benefits of vaccines far outweigh the risks. Whilst the government claims serious adverse events to vaccines are rare this is not supported by adequate scientific evidence due to the shortcomings in clinical trials and long-term surveillance of health outcomes of recipients.

A close examination of the 'Swine Flu' 2009 vaccine and the vaccine for human papillomavirus (HPV), intended to prevent cervical cancer, shows shortcomings in the evidence base and rationale for the vaccines. This investigation demonstrates that not all vaccines have been demonstrated to be safe, effective or necessary.

It also concludes that the government's claim that the benefits of vaccines far outweigh the risks cannot be sustained due to the gaps in the scientific knowledge resulting from unfunded research and the inadequate monitoring of adverse events after vaccination.

THE CONFLICTS OF INTEREST IN MANDATORY VACCINATION (12+ VACCINES) IN AUSTRALIA'S SOCIAL SERVICES POLICIES By Judy Wilyman PhD

In Australia from 2005 - 2014 the chair of the Australian government's vaccine advisory board (ATAGI) who recommends new vaccines for the national vaccination program was Terry Nolan. Prior to this job he was the head of the largest vaccine research and development program in Australia – VirGo (1990 – 2005) – at the Murdoch Children's Research Institute (MCRI). Further, the mandating of 12+ vaccines for social services in Australia (No Jab No Pay/Play legislation) was promoted to Australians through the mainstream Australian media that is ~80% owned by Rupert Murdoch and who established the MCRI with a contribution of \$5 million in 1985.

During this decade Terry Nolan's role was to recommend vaccines directly to the Health Minister and many new vaccines were added during this decade. He was also the deputy-chair of the National Health and Medical

Research Council (NHMRC) at this time and in this role he influenced the direction of government funding for new research projects on vaccines. This is significant because areas of science can be systematically de-funded to produce areas of ignorance in scientific knowledge. This results in 'undone science' when important areas of science are left unfunded.

My PhD thesis describes the areas of "undone science" in vaccination policy that have led the Australian government to make assumptions about the safety and efficacy of vaccines in its national vaccination policy, instead of using empirical knowledge of the benefits and risks of vaccines. These assumptions are even hidden from researchers because the government uses mathematical modelling with algorithms that do not reveal to the public the parameters of 'risk' or 'benefit' that are being used to claim that a vaccine is a costeffective measure in the population.

The potential conflicts of interest of Terry Nolan were never publicised on the government website from 2005 – 2014. Terry Nolan retired in December 2014 to return to his role as head of VirGo at the MCRI and in advising the World Health Organisation (WHO) on influenza policy on the SAGE committee. The Australian government did not publish the Conflict Of Interest of vaccine advisory board members on the website until February 2015.

"Researchers have discovered what they described as a "significant" mutation of the novel coronavirus, which they believe "raises the alarm" that the search for a vaccine could become "futile" down the line. The study, published on the biorxiv.org repository, notes researchers were able to analyse a sample of SARS-CoV-2 from India on January 27 and found a mutation that "leads to weaker receptor binding capability." The receptor, known as ACE2, is an enzyme in a person's lungs.

"The discrepant phylogenies for the spike protein and its receptor binding domain proved a previously reported structural rearrangement prior to the emergence of SARS-CoV-2," researchers wrote in the study. "Despite that we found, the spike glycoprotein of SARS-CoV-2 is particularly more conserved, we identified a mutation that leads to weaker receptor binding capability, which concerns a SARS-CoV-2 sample collected on 27th 26 January 2020 from India. This represents the first report of a significant SARS-CoV-2 mutant, and raises the alarm that the ongoing vaccine development may become futile in future epidemic if more mutations were identified."

The research has not yet been peer-reviewed. Despite the ominous discovery, the researchers were also able to discover that SARS-CoV-2 "has a much lower mutation rate and genetic diversity" than severe acute respiratory syndrome (SARS), which appeared in China in 2002.

The researchers also discovered "the spike (S) protein encoding gene of SARS-COV-2 is found relatively more conserved than other protein-encoding genes, which is a good indication for the ongoing antiviral drug and vaccine development."

outbreaks of ebola-type viruses occurred, led him to Germany and Yugoslavia in 1967. In 1967, the strain now known as Marburg struck three vaccine production facilities almost simultaneously. Two outbreaks occurred in two West German cities and another in Yugoslavia. Oddly the virus then 'disappeared' until 1975 when it 'reared its ugly head' in South Africa. Then, less than two years later two larger outbreaks erupted in southern Sudan and northern Zaire.

1969 World Health Organisation report

In 1969 the World Health Organisation released its second five-year research report on viral experiments it had funded or conducted since 1959. The report stated: "In the years 1964-68 the principal advances in virology were in knowledge of the fundamental structure of viruses and cells and of their interrelationship and interactions. A much greater understanding was gained of the natural behaviour of viruses as infectious agents, of the pathogenesis of virus diseases and of the means of controlling many of the common virus diseases - generally by improving existing vaccines or by developing new ones. Though direct proof of a causal relationship between viruses and human cancer still escapes the numerous investigators working on this subject, the quest continues to be energetically pursued. The hypothesis that at least some malignant neoplastic diseases such as leukaemia are associated with virus infection is perhaps even more strongly expressed now than in the past."

All this happened during the so-called 'cold war'. At the time, "Russian and American researchers were privy to the same vaccines, viral samples, and information about how the human immune system could be bolstered or destroyed by old and newly developed germs, including those produced from monkey viruses."
