Richard Wurmbrand has written a book, *Marx and Satan*, Crossway Books, 1986, (shipment from General Birch Services Corporation, Belmont, MA02178). F. R. Duplantier comments on this book in an article “*The Devil Made Him Do It*”, (*The New American*, 8th December, 1986): “In *Crime and Punishment*, famed Russian novelist Fyodor Dostoyevsky depicted with brilliant insight the criminal’s compulsion to confess. It is not surprising that the Communists, the greatest mass murderers in the history of the world, share this compulsion — though their moments of candour have more the air of *bragadoccio* than penitence. To a man, the Soviet leaders from Lenin to Gorbachev have boasted of their intentions to enslave the world. Unlike the common criminal, however, who expects to be punished for the crimes to which he confesses, or to be restrained from the commission of those he has acknowledged plotting, the Communist who publishes his evil deeds and evil plans seems confident that he will go unchallenged. His impunity derives from the inability of his intended victim to understand his motivation. We simply cannot fathom why anyone should want to enslave, torture, and murder millions of people. And because we cannot understand the inspiration for such inhumanity, we tend to discount the reality of it. There was a time when all men believed in the existence of evil, knew its origin, and understood the means with which to combat it; but in this ‘complex’ age of ours we are no longer satisfied with simple answers, and our ‘sophistication’ has rendered us defenseless....” (continued next page)

In an earlier age we might have been able to dismiss Richard Wurmbrand's *Marx and Satan* as a superfluous work....His thesis that the evil wrought in the world by Marx and his disciples can only be explained by Satanic influence, would have seemed axiomatic....

The question is: Is Wurmbrand justified in assuming that it is possible to prove anything to people who refuse to believe? And if his book does convince our modern sceptics - as it should - that Karl Marx was a Satan worshipper whose overriding goal in life was to lead as many men as possible into damnation; will they also conclude that Satan does exist, or will they merely be amused by Marx's 'gullibility'?

In a first chapter entitled '*Changed Loyalties*', Wurmbrand documents a dramatic shift in the young Marx's first allegiance.

'In his early youth, Karl Marx professed to be and lived as a Christian....But Marx was not out of his teens before he became profoundly and passionately anti-religious. In a poem entitled '*Invocation of One in Despair*', he made his bold confession, 'I wish to avenge myself against the One who rules above'.

Another poem, '*The Player*', is even more ominous;... Wurmbrand explains that 'in the rites of higher initiation in the Satanist cult, an enchanted sword which ensures success is sold to the candidate. He pays for it by signing a covenant, with blood taken from his wrists, agreeing that his soul will belong to Satan after death'.

Devil's Advocates

The volume and intensity of Marx's self-incrimination are overwhelming. And Wurmbrand cites similar material from the pens of Lenin, Stalin and other prominent Communists. To disbelieve that these men were dedicated Satanists, we must deny both the physical evidence of their evil ('*By their fruits you shall know them*') and their own testimony...."

In *The New American* of 19th January, 1987, a correspondent, Marlene N. Metzinger, referring to the above article by F. R. Duplantier, writes: "Having never before heard Karl Marx described as a Satan worshipper, I sought out biographies of him...Robert Payne has included in their entirety Marx's poems *The Player* and *Nocturnal Love*...In short, Payne confirms Richard Wurmbrand's appraisal of Marx as an accomplice of the devil: 'The pact with the devil was the central theme of *Oulanem* and appears in various disguises in many of his early poems. It was a subject on which Marx brooded frequently, not only in his youth. Goethe's *Faust* was his bible, the one book which he regarded with unreserved admiration, and he liked to read out the verses of *Mephistopheles*, just as he liked to sign himself "Old Nick". He had the devil's view of the world, and the devil's malignity. Sometimes he seemed to know that he was accomplishing works of evil'.

INFORMATION, PROPAGANDA AND PSYCHOLOGICAL WARFARE By Arnis Luks

In my research for this week I came upon a work by Ivor Benson titled '*The Opinion Makers*'. This particular copy was autographed by the author to the recipient in 1967. Each chapter precedes by a thought, of which Edmund Burke provided for our *On Target* for this week.

It should be clearly understood that the word "individual" is used in its original undefiled sense to mean One Person, as distinct from Society or Community. It does not mean that the leftists "fragment of mankind", something to be moulded with the rest, "according to the plan", but the Person who, whether he knows it or not, is responsible and answerable for what he does or allows others to do with him, and answerable to himself, his family, his community and his God.

This book on Information, Propaganda and Psychological Warfare is addressed to this individual.

Benson documents instances of when and how the mainstream media exercised power over people's thinking. Whether it be by promoting a certain individual over another, a certain point of view over another, or deliberately omitting valid reporting of dissenting

views. By the Main Stream Media I refer to the public and private press (*all forms of printed and broadcast information*), pulpit (*all forms of moral persuasion*), and platform (*all forms of political or industrial persuasion*).

Benson highlights the subversive manner of the mainstream media in weakening public resolve against the Communist subversion and takeover of Rhodesia and later South Africa. The word propaganda does not do justice to the treacherous role played by the MSM.

Today's news cycle substantiates the COVID-19 threat again and again. There is no critique, or alternatives to the proclamations that the Executive (with bureaucracies) are using to hold people under house arrest. There is no critique, or alternatives to managing or enhancing personal immunity levels. The MSM, whether press or pulpit or platform, mentions nothing of the Bolshevizing of our nation. They are an integral part of the war against the individual in favour of the collective, managed by the technocrat, on behalf of the money power.

The free press is not free at all. It is bought and paid for. Benson mentions repeatedly the ownership of the instruments of the press as critical to manipulating of the public mind. We see in the Conservative press espousing and favouring totalitarianism in the form of capitalism. The taxpayer subsidised ABC, along with the Fairfax

instruments is promoting the other side of the yin yang.

It's worth noting that at a sports event in USA, when the players 'took a knee' during their national anthem in support of black lives matter, the audience booed. Interestingly Israel Folau, at another separate event did not take the knee. He only kneels before God.

The True Role Of The Press

*Here shall the Press the people's right maintain,
Unawed by influence and unbribed by gain;
Here Patriot truth her glorious precepts draw,
Pledged to religion, Liberty and Law.*
- Motto of Salem Register (1800-ca.1911).

There is such a thing as the "press ideal". It may be summarised as reporting truthfully. It is a duty of prime importance, as the properly appointed guardian of precious public values. It exists primarily for the purpose of rendering public service and is therefore different from other commercial undertakings. In many parts of the world the press is not trusted at all. In Australia it is biased or skewed towards two different totalitarian ideologies. It is serving sectional interests in the power struggle of our times - the war against the individual.

The public has a need for sound information. If the press fails to provide that then it is failing in this "press ideal". A genuine "press ideal" requires partiality and impartiality. A healthy society requires a certain amount of internal tension. It needs to hear competition of interests and of ideas. There must always be such oppositions of interest: as between those who employ and those who are employed, the producer and the distributor, city and country. There must also be necessary and inevitable tension between rulers and ruled, between people and government. There are rivalries and oppositions of interest between church and state and even amongst churches, all healthy rivalries if kept within bounds. The list goes on. In these wide and varying opinions, the vigorous pitting of ideas against each other produces the best results for all. The suppression of ideas sterilises thinking and produces fear. A news source can provide a service of tremendous social significance. It breaks down barriers of concealment, as we noted on today's front page by the Qld. Premier with corruption.

With the centralisation of power, has come the centralisation of information. This produces sterile opinions. This is scorchingly obvious with the COVID-19 lockdown and no other medical alternatives.

Self deceived and self betrayed, journalists present to their thousands or even millions of readers and viewers a confused, contradictory, unintelligible picture of the world, thus helping to spread discouragement and neurosis. Is it any wonder the rampant sense of purposelessness of existence and the meaninglessness of life when our minds are shackled to alien purposes, generally originating from the minds of the owners of these outlets, when so many of the meanings put into our

minds are sourced for those alien purposes.

Only when our activities are truly ours, illuminated by knowledge and thus serving our true purposes. Only then can we enjoy security, feeling that life is rich and exciting and purposeful. The mainstream media betray much by betraying the genuine "press ideal".

The history of Rhodesia being pushed over the precipice of disaster by propaganda and psychological warfare was conducted predominantly by an alien press: if not alien in language and nationality, certainly against the cultural wealth and values and well being of the people of Rhodesia.

How is a scientist meant to understand his craft if he does not deal in the discipline of facts. And then based on these facts places them in context, in the real world to understand their ramifications. So it is with individuals. They must be provided with the truth as it is — warts and all — if they are to make a considered judgement. No one can form any idea of the potency of the propaganda weapon as a means of overcoming political resistance, nor conform any clear idea of the danger of the propaganda weapon, who has not gained a clear insight into the real meaning of information and the processing of this information in the scheme of life. It is no longer safe to react normally to all the information that reaches us from many different quarters. We must recognise that our minds have been turned into a battleground in that there can be no victory which does not begin with truth and factual information. Every source of information is as vital to the living organism as air and water. Nature has provided every living creature with ingenious means of gathering information — the information it needs — and of processing this information and translating it into purposeful activity.

For any army, information is nearly always a matter of life or death, and the Intelligence Corps is to the Army what eyes and ears and nose and brain are of the human individual in time of trial and danger. It is not enough to criticise our own press and to point out its innumerable faults of commission and omission. What is needed is a clear insight into the genuine "press ideal" and set the same objective for ourselves. This will enable each one of us to discern whether they are being well served or not by a particular source of information. And on the basis of this discernment, to promote this "press ideal" by becoming the "free press" themselves.

Most people have contact lists, and from their own array of sources of accurate news articles, to forward these same articles onto their contact lists. Necessity is the mother of invention. These are only my thoughts. I'm sure you have many other options that can build from this point. The question is not 'what can we make them do'? It is more of What can we do to achieve the 'press ideal'?

*This night is far spent, the day is at hand:
let us therefore cast off the works of darkness and
let us put on the armour of light. - **Romans 13:12***

Let us stop waiting for a magic solution to the problems of this misuse of information by our mainstream media. Let us each become part of the answer to achieving the “press ideal”.

Limited Constitutional Monarchy

I received a copy of a letter addressed to the Governor of Victoria. Within the letter was a request for Her Excellency to address the Premier about his vicious rule. **This may encourage other letter-writers to follow suit.**

I note in S. 23 (1) of the **Emergency Management Act 1986**, that it is the Premier who has the authority to declare a state of emergency, not the Governor. It is also the Premier who has the authority to revoke or vary a declaration. I also note that in S. 23 (1A) (7) the Premier must report to both Houses of Parliament as soon as practicable after the declaration if Parliament is then sitting and if Parliament is not then sitting as soon as practicable after the next meeting of Parliament. The Victorian Premier has recently suspended Parliament.

In my mind this leads to justifying Petitions to the Governor, on the basis of the failure by the Premier to report to Parliament, to revoke the Premier’s commission and call an immediate election. This allows the people of Victoria to accept or reject the **'declaration of a state of emergency' and extended lock-down** - using the Petition to the Governor and vote as a VETO mechanism.

We live in a Federation of sovereign states operating under a Limited Constitutional Monarchy. The ultimate authority federally and for every sovereign state is ‘the people’ under the agreements we refer to as our Constitutions. The Federal Constitution is a limiting document, defining the ‘head of power’ (the limits) of the Federal Government.

Sally Fallon Morell, head of the Weston A. Price Foundation, empowers us to take our health into our own hands. Through a nutrient-dense diet, we can strengthen our bodies naturally and improve our ability to confront what may come our way.

Sally offers practical tips for boosting immunity including:

- taking 1 Tablespoon of coconut oil per day
- eating liver once per week
- drinking bone broth regularly for detoxing
- including saturated fat to safeguard respiratory health

She goes into detail about the foods that nourish and protect our immune system. She discusses the role of **vitamins A, D, C, and saturated fats**. Douglas mentions in ‘*Realistic Constitutionalism*’ that: producing a new law should be as difficult as altering a Constitution. We are experiencing ‘law by decree’ by an unaccountable Victorian Executive.

Douglas Social Credit presents the case, in my view the correct case, that we live in a time of material abundance but spiritual poverty. Solzhenitsyn warned us: why did these things happen? Because men forgot God. Marxism is Satanic. You cannot “render to God the things that are God’s” if Caesar is ‘all’. Caesar must again be limited. We have, in my view, mostly good constitutions, built up from the lessons of the past. In the first instance we need to use ‘those’ as our first wall of defence. Behind that wall is Habeas Corpus, Trial by Jury, Innocent until Proven Guilty, Magna Carta and the Common Law. We have a rich cultural history of resisting and overcoming tyranny. Our brave soldiers died in their thousands in the belief and hope that they were resisting evil and overcoming tyranny. It is now our turn to resist and overcome evil and tyranny. ***
