“NO ONE HAS DIED FROM THE CORONAVIRUS”

**Important revelations shared by Dr Stoian Alexov, President of the Bulgarian Pathology Association
Reported by Rosemary Frei and Patrick Corbett**

A high-profile European pathologist is reporting that he and his colleagues across Europe have not found any evidence of any deaths from the novel coronavirus on that continent.

Dr. Stoian Alexov called the World Health Organization (WHO) a “criminal medical organization” for creating worldwide fear and chaos without providing objectively verifiable proof of a pandemic.

Another stunning revelation from Bulgarian Pathology Association (BPA) president Dr. Alexov is that he believes it’s currently “impossible” to create a vaccine against the virus.

He also revealed that European pathologists haven’t identified any antibodies that are specific for SARS-CoV-2.

These stunning statements raise major questions, including about officials’ and scientists’ claims regarding the many vaccines they’re rushing into clinical trials around the world.

They also raise doubt about the veracity of claims of discovery of anti-novel-coronavirus antibodies (which are beginning to be used to treat patients).

Novel-coronavirus-specific antibodies are supposedly the basis for the expensive serology test kits being used in many countries (some of which have been found to be unacceptably inaccurate).

And they’re purportedly key to the immunity certificates coveted by Bill Gates that are about to go into widespread use — in the form of the COVI-PASS — in 15 countries including the UK, US, and Canada.

Dr. Alexov made his jaw-dropping observations in a video interview summarizing the consensus of participants in a May 8, 2020, European Society of Pathology (ESP) webinar on COVID-19.

ONCE POWER IS SEIZED, WHAT WOULD HAVE PREVIOUSLY BEEN CONSIDERED ILLEGAL, NOW THROUGH LEGISLATION (LICENSING) BECOMES LEGAL By Arnis Luks

The state (dominated by sinful man) is giving itself the right to tear up our constitutions, our common laws, our ancient traditions and medical self-determination, our freedom of thought, and speech, and movement, not on the basis of excessive morbidity, but on the ruse of a spurious test for COVID-19 (false positives and all) and also which has just surfaced, the deliberate falsification of statistics to amplify perhaps 10 or even 100 times the actual number of COVID-19 cases (probable, not confirmed).

The push for world government is going full throttle - for broke. Truth is of no consequence in this campaign to seize power over the entire world. Our Prime Minister on the front row of this campaign alongside the Victorian Premier, have locked down the entire nation to bring this about. The perceived threat of a second wave, and any subsequent waves, is simply to keep the thumb screws of totalitarianism in place.

Currently, morbidity from COVID-19 in Australia stands at 104 with an average age around 80.

Do you remember Lindy Chamberlain's incarceration based on a "reagent" (think of a pH litmus test), proven to give a false positive by the Royal Commission. Scientific methodology has never demonstrated infallibility. The Y2K threat was false - Bill Gates may wish to forget that one. The climate models were false. The mad cow disease models were false. The COVID-19 models are false. Our rich Christian cultural heritage is being stolen from us for this bowl of pottage (in answer to the fear of COVID-19). We now need to look for the early beginnings of corporate fascism

When communities yielded to the mass medication of their water supplies with the addition of the toxic poison fluoride, they essentially authorised government to make this very personal decision for them. Government seized on this lapse of judgement with the perceived threat of increased caries. Nearly all communities in Australia now have this toxic poison administered to their water supply. The individuals in society who wished to respond against this mass medication, then needed to make their own arrangements for clean water supply.

Around the same time governments determined that a 'not yet born human being' did not have the same right to life as other human beings that were already born. This determination accelerated over time from 'up to 12 weeks after conception', then to 20 weeks, and now to the point of full-term. The state has mechanised wholesale human slaughter, whether in war or by other means. We, in our hypocrisy, somehow rationalise that China's harvesting of human organs from born humans is somehow more unethical than the west's harvesting of human organs from the not yet born.

Today's heading "all lives matter" is in stark contrast to the greatest holocaust in human history, the mass killing of the born and not yet born by the state, all licensed of course. The state is currently in negotiation in regard to the infirmed and aged. They are next. The state will then come for you as it did in the Soviet and China and Pol Pot etc. etc. etc....

The real pandemic, which never receives a mention, is of chronic autism spectrum disorder, allergies, asthmas and autoimmune diseases. The players of this very real human drama have demonstrated an ethical standard equal to or worse than what may be expected from organised criminals.

These hard-hitting statements, of which most would shun, all need to be placed on the table. Our leaders are not "ours" at all. They have no personal bond or loyalty towards the people of this land. Their loyalty is directed to some other.

Dominance Hierarchies

Russian Pres (for life) Vladimir Putin, similar to Xi from China, is ensuring his permanency at the realm of Pres of Russia. Once power is seized, the temptation to never relinquish is so great, in fact humanly impossible to resist. He is no better nor worse than any other

historical leader. The question for us is "Is our PM any better?" Or "Is the Victorian Premier any better?" I think not. They have both subjected the citizenry of this nation to a foreign power now labelled world government. The rest is just the facade, the smoke and mirrors of what was once a limited constitutional democracy.

Karl Marx misdirected political energy towards the ownership of the means of production — state ownership of all assets — instead of directing energy towards the shared ownership of the fruits of production. Marx never directed any significant energy against his sponsors the money power, the real seat of power of this age.

The power structure of communism is the dominance hierarchy, also propounded by Canadian Prof Jordan Peterson as the model on which societies are structured. This is false and is utilised by Prof Peterson to mask the sinister nature within his own message. Behind the facade of anti-Marxism lurks the same totalitarian model as Marxism, just under a different covering. This is not easy to comprehend and requires effort and study.

The neo-liberal thought-stream or classic liberalism was sponsored by this same money power, which falls into the same model of dominance hierarchy thinking, claiming falsely (by Prof Peterson) that capitalism is responsible for lifting the poor out of poverty, (in actual fact our cultural heritage is responsible for this legacy). Capitalism (monopoly by its nature), is directing energy towards centralising wealth and power further. Once power is seized, (the ability to counterfeit money on demand), what would have previously have been considered illegal, now through legislation (licensing) is legal - *counterfeiting becomes modern licensed banking practices since 1694 with the Bank of England.*

Monopoly is about accumulating wealth and power. Misdirecting energy towards the spoils by market manipulation encourages the devious and shrewd, misappropriating the cultural inheritance "from the poor", the ones who actually need it the most. The latest, suggestion medical passport (vaccines, WHO, Bill Gates, Anthony Fauci) is a policy of monopoly, not of freedom of choice to manage your own body (personal and private) as you see fit. No question of clean air, water and healthy food rather than mandated medication.

Free enterprise—let us be clear on this—is not capitalism. Free enterprise is essentially entrepreneurialship in the pursuit of providing a service, of which individuals are free to pick up or put down as they choose. This entrepreneurialship risks reward or failure at each and every turn.

Directing our own energies towards "the least of these", not through charitable handouts though that in itself is a good, but rather ensuring that the cultural inheritance that rightfully belongs to every individual, especially the least, is directed towards them is a very much greater good — the drum that should be banged the hardest. The **National Dividend** places

this economic-voting-right into their hands, where it rightfully belongs. It is not sourced from what anyone else currently has, but is an issue of legitimate credit.

The **National Dividend**, when directed towards every individual, stops the wholesale theft and pilfering from the least of these, by changing money into a ticket system (fit for purpose), that the fruits of production becomes available for consumption. The power usurped by the fraudulent issuing (now licensed) is deconstructed, being placed at the foot of every person as their rightful cultural inheritance from past generations of scientists and industrialists into the 'money vote'. Policy directed towards the good, towards the least of these.

In this age of plenty (materially at least) we have enormous insecurity. The state (dominated by sinful man) indoctrinates the young and de-constructs the traditional family unit. The state is manoeuvring to be the employer for all. What the state gives the state can take away. So the current financial hiatus is to appease the masses while we go through this period of normalisation. Significant manoeuvring is going on behind the scenes while we are in, what is now becoming an extended lock-down.

First Things First

Individual people come together, firstly to form a basic family. Then families come together to form a small community. Then communities come together to form a city-state. Then city-states come together to form a nation-state. At each stage of this coming-together there must exist mutual love and cooperation — a basic set of beliefs of how to get on, an agreement with the rules, and an acceptable structure with which to enforce what is agreed to. As we are attacked in this pincer movement by Cultural Marxists on one side and Neo-liberalism

on the other, these areas of agreement are being deconstructed. This deconstruction has been going on at an accelerating rate for at least 50 years. The prophet, the seer, the natural leader have not banged the drum loud enough. It is now up to every one of us.

“New Zealand Prime Minister Jacinda Ardern has joined 80 other politicians in voting against an attempt to require health professionals to give medical help to babies born alive after ‘failed’ abortions.

The Care of child born after abortion amendment was brought forward by the MP for Tamaki, Simon O’Connor at the committee stage of the Abortion Legislation Bill. The vote was lost 37 votes to 80.

The amendment would have required, that if a baby was born alive following a failed abortion, a qualified health practitioner or any other health practitioner present at the time the child is born, would have a duty to provide the child with appropriate medical care and treatment.

It would have also required the medical care and treatment of a child born as a result of a failed abortion to be no different than the duty to provide medical care and treatment to a child born other than as a result of an abortion.

Data from the few other countries where there are similar extreme abortion laws to the one proposed in New Zealand shows that it is likely that many more babies will be born alive following abortions, as it will in practice allow abortion for any reason between 20-weeks and birth – when unborn children are much more likely to survive a ‘failed’ abortion.”

THE POSSIBLE SPIN-OFF FROM COVID 19 - National Director

There are so many stories around about this pandemic, it becomes difficult to fathom fact from fiction. By way of example, the number of deaths around the world attributed to Covid 19 are massive, thus creating fear among the population. However there are stories of how the figures are manipulated. Sick people may well have been suffering from any number of pre-existing illnesses prior to contracting the virus, yet their death is recorded as resulting from the virus.

Compare the publicity about the deaths with the fact that a very small percentage actually die. Something like less than 2% of virus sufferers. This is about the normal figure in any year for those infected with the normal influenza. The virus is so mild that in many cases people are completely unaware of having contracted it.

While it is not confirmed that Covid 19 has been released deliberately as an exercise to see how communities around the world will react to the imposition of numerous restrictions; we have often been told that events, apart from the likes of earthquakes and tsunamis, do not just happen. They result from someone’s plan.

Whether there is a plan behind Covid 19 or not, the restrictions are already delivering vast changes and what about the chances of our economy returning to normal? Maybe the depression of the 1930’s where there was a severe shortage of purchasing power, has been a lesson not forgotten because around the world money has been pumped into infrastructure but more importantly, to people out of work. This is at least a saviour in the short term. The massive amount of money committed to this purpose has reached levels never seen before and many are asking how we will deal with it?

The answer will show whether there is a plan ahead.
