**THOUGHT OF THE WEEK: PREFACE.** In the life of every man there comes a time when he must face up to the solemn procession of the old order passing and turn to salute the new order that arises, deciding with his own conscience where lies the duty of his own generation standing between the two as a powerful factor in the whole course of history. In this Australia of ours, as in every other country of the modern world, that time has arrived, and each of us must decide for himself whether he will stand with a civilisation that has debauched itself with a gigantic criminal foolishness or give the best that is in him to the recasting of the order of society to eliminate those ugly factors that have made want a mockery of divine bounty and placed human life on the altar of sacrifice to the false gods of personal aggrandisement round which our machine age has grouped itself.

In the (1929 depression-ed) years that have slipped away we have lived with poverty, making personal acquaintance with the demoralising effects of want; and, in the twenty years that I have given to the Parliamentary service of the splendid people of this, the greatest land that God has bestowed on man, I have striven to straighten out those sharp corners where so many of my countrymen have encountered miseries and hardships that are obviously outside the divine dispensation of human society. And in that striving I have come to recognise a force that is stronger than society, secret and swift, that secures itself behind the charter of exploitation of the common people of the world. It is a privileged and select autocracy, which knows no nation and cherishes no faith, and has stolen for itself from the long evolution of modern civilisation an assumption of power which it now claims as a right.

And where I, and others, would seek to lead the people through to freedom we have encountered this hidden hand entrenched in ramparts that have become almost unassailable.

Enthroned in our society is a hierarchy of financial anarchists playing with a world of men and women for sheer personal gain, putting them to work under the whips of hunger, throwing them into idleness to keep them in discipline, massing them for war, dividing them in peace — and from every activity into which it deploys them drawing toll in gold, counted over and over in human tears and blood.

To my people I give the call to throw off this yoke, striking at it through the one chink in its carefully constructed armour; and in the following pages I have endeavoured to point the way by disclosing the methods by which this power works and exposing the immoral sacrifice of whole nations of people, and particularly of this young nation of ours, to the cause of greed.

I can see the Old Order passing and I salute the New, hoping that the facts I am about to reveal will inspire my fellow Australians, who have been cheated of the heritage God has given them, to stand solidly... for the restoration of our civilisation on the foundations of justice and equity and the rehabilitation of our national economy on a real basis of lasting prosperity expressed in happiness, comfort, and security for the whole of our people.

### THE GREAT FIGHT By Arnis Luks

In my research for this week, in his book “*Why I Fight*” by JT Lang, I found that this former Labor Premier of New South Wales’ greatest battle during his political career was against the money power.

JT Lang was dismissed by the then governor of New South Wales, Sir Philip Game because of Lang’s attempt to wrestle the state finances and Pension Funds away from central banking claws. Bearing in mind this occurred in 1932, a mere 8 years after the conservative “Nationalist Party” emasculated the People’s Bank - the Commonwealth Bank of Australia - at the behest of this same money power, and in the middle of the depression years when major banks were making an absolute financial killing, as documented in his book “*Why I Fight*”.

One item worth remembering here is that the fledgling Federal Labor Government, within which Labor politician King O'Malley played an integral part in establishing the People's Bank, the Commonwealth Bank of Australia happened in December 1911.

Another more current historical fact is the progressing of the internationalising of our economy, initially by the Whitlam Labor Government, a policy continued by successive Labor and Liberal Governments with the implementation of the LIMA Agreement, we find the final sell-off of the People's Bank under Labor leader Paul Keating and the TPP signing under the Coalition.

This illustrates the conflicting policies emanating within the Labor (and Liberal-ed) Party, which is not unique. In each of the various colours of our political persuasions we find conflicting policy outcomes. Greens are declared marxist-totalitarian but present themselves as environmentally responsible. Yet totalitarian regimes the world over abuse the environment for personal profit while securing power for the leadership. Consider the annual display of military might by both Soviets and Chinese administrations - the ability to destroy on a gigantic scale. A dual physical threat to both enemies of the state and their own people.

Blues present themselves as conservative (business), but promote totalitarian financial policies of the monopolist von Mises variety - capital-totalitarianism.

Nationals (light-brown maybe) are all for the farmer, but policies like TPP always protect and promote the interests of international-corporations, while farmers and the rural sector suffer badly, so also totalitarian.

There appears to be no legitimate alternative to totalitarianism from any political party. The structure of political parties is based on power, promoting a tribal-base (we can manage it better than the other lot) while doing the bidding of the money power, the root of totalitarianism. None accomplish policy outcomes that benefit the individual. There is always a promise of better times ahead that never eventuate.

***Douglas Social Credit accomplishes policy outcomes now - immediately - for the direct benefit towards the individual, that eliminate rapacious debt and place financial power in the National Dividend at their feet.***

Australians are kept divided by political-colour-loyalty and need to become united towards policy outcomes: ***security, prosperity, freedom of thought, speech and movement.*** This will not happen until sufficient individuals use their initiative to restore our ancient freedoms and regain control of policy outcomes.

### **At The Counter**

A recent visit to our local state representative's front-counter, staff initiated a discussion about the financing by the federal government of jobseeker and job keeper allowances. Reports are now coming in that acceptance requires future beholding, similar to student loans towards the federal government. While the methodology

to generate new finance is not unprecedented, (John Maynard Keynes deficit budgeting), the rapid escalation of debt is 'unprecedented' even in times of war.

The private banks are quite happy to keep lending to service existing 'loan interest' while total debt is going through the roof. The politician's staff were happy to highlight that this new logarithmic-debt would be paid for by future taxation - from 'whom' if there are no jobs?

Australia is already swimming in debt and no one is interested in this vital question of "where does all this new money come from?" - out of thin air says the Bank of England's first quarterly report 2014. Jack Lang's fight is now ours to win or lose for future generations. The outcome — financial slavery or freedom from want.

### **None Dare Call It Treason**

*None Dare Call It Treason* was a bestseller in 1964, when USA conservative Barry Goldwater ran for President. Written and published by John A. Stormer, it professed to reveal Communist infiltration within the American institutions. Most articles following this, or similar theme, suggest treason spreads predominantly from the left. The narrative never looks at the treason from the right. Several of today's News headlines reveals a long and sordid record of reprehensible acts from within the ranks of the right.

Prof Peter Ridd's loss at the Federal Court of Appeal needs to take several important considerations into account. The appointment of any Vice-Chancellor (to James Cook or any other university), and the subsequent political campaign to silence Prof Peter Ridd, (or any other person holding scientific instead of politically correct views), needs to be considered as part of a long-term strategy forcing compliance and silence.

Both, in federal and state spheres, governments are well capable of exerting enormous influence on all appointments within these institutions, whether tertiary, seminary or industrial appointments. Yet, they did not, just stood idly by while this phenomena unfolded.

***The silencing of scientifically observable opinion based on repeatable phenomena, is a political decision.***

Both, public servants and educational institutions are working together for a common political purpose, to shutdown the western economy using climate change propaganda, and now covid-19 propoganda. Universities are business-like political institutions, rather than educational and scientific centres of excellence. No need to build re-education camps, they already exist in our universities and other institutions of learning, also the handmaid of money, the Main Stream Media. The communist/capitalist nexus is alive and well.

In regard to any court and public service appointments - the public needs to be in constant contact with them all. They must not be aloof and separate, but involved and in close proximity. They need to be local to the affected community to ensure no vested interests enter the fray. Law, instead of being common and accepted amongst

the people, has now become arbitrary and proclaimed virtually every other weekend, without the scrutiny of open, public and recorded debate within the hallways of Parliament. Courts have become politically active, rather than upholding the common law and the Constitution of the Commonwealth of Australia, with our federal neo-liberal government's inaction again leading the way. There is a clear separation between the electorates and their representatives, which should never have occurred.

The neo-liberals and internationalist labor - twin thistles, cannot produce figs. If you want figs we need to rip out the thistles and plant figs. Eric Butler warned us in his booklet "*Releasing Reality*", that evil cannot be defeated by reform, it must be abolished completely. So it is with the political parties (and educational institutions), which undermines our parliament, which removes the recording and accountability of debates from Hansard into the political party room, where all sorts of manoeuvring takes place away from the public gaze. Lobbyists and donors hold the sway of their collective opinion, instead of the voting-electorates - the best democracy and learning institutions that money can buy. The neo-liberal right continues on this fine tradition of political appointments to these educational and legal institutions unabated. Their loyalty is somewhere else, certainly not here amongst their own people.

### **Thought Processes and Treachery**

Neo-liberal and conservative are two different thought processes and hold two distinct philosophies. One has a loyalty and preference towards profit at all cost, the other has a loyalty to family and community. The two are irreconcilable. Interestingly the speech by Bob Hawke addressing the Fabian Society 1984 is also available at the same link as a continuation to the theme of conflicting thought processes within political parties.

Traditional Labour is orientated towards their fellow man and community, against the exploitation from the moneyed class. Thought For The Week by Jack Lang shows some of this. King O'Malley who was instrumental over many years to establish our Commonwealth Bank 1911 - 1924, was also such a man. Whereas international-socialism of the Paul Keating, Bob Hawke, Gough Whitlam types directed energies towards things international and not local - towards central power. There is treachery within all political party camps.

John Howard's recent posturing about the bullying behaviour of the Chinese leader Xi, yet he and his governments did nothing to foster a proud cultural heritage, an homogeneous society, within our institutions. His, and previous and successive governments of all persuasions continued unabated to disassemble our

economy and culture through implementation of the LIMA Agreement, combining together with massive immigration, both colours denying with their lips what they were doing with their hands. Along with the deconstruction of our wonderful history through these same educational institutions. Vested interests promoted these policies to exploit short-term profit weighed against social deconstruction and instability.

### **History Revisited**

I recently had the pleasure of reading the thoroughly researched work of "*Capt (James) Cook's Epic Voyage*" by Geoffrey Blainey, which included the uncovering and mapping of the east coast of Australia. It is an important historical chapter in Australia's short history. Other very important works are "*Botany Bay*" and "*The First Fleet - The Real Story*" by Alan Frost. These three chapters in Australian history prepare the soil of our culture for the standing to attention, the raising of the flag and the singing of our national anthem. Yet the political appointments to our learning institutions tear these narratives apart.

Unaccountable individuals within spheres of influence are capable of making hideous decisions affecting many generations. Flowing out from these tertiary institutions are the next generation of teachers, politicians and industrial and church leaders. It is no wonder the Communists target these institutions, and the neo-liberals appoint them to senior roles. They are from the same pod. The capitalist/communist nexus.

### **Root of the Cancer Against Direct Democracy**

All political instruments like 'the vote' should be considered under the banner of 'direct democracy'. But, while our political, educational and cultural/religious structures are all under the domination and control of the money power, pursuing 'only' direct democracy may not resolve these issues in the long term. We must go to the root of the evil, the power of the issuance of credit, which must also be overcome as we pursue our goal of restoration of *political democracy* to also achieve *economic democracy*.

The financial system as it is currently structured is a parasitic cancer on society, run and ruled by anarchists. It permeates every cell of the body cultural and is causing its imminent death. To resolve these issues of treachery we need look no further than the natural world.

Considering the observable phenomena of blood cells during a live blood analysis, the white cells move about and make direct contact with each red cell. This phenomena of immediate and direct contact is also observable within a beehive, where the Queen will move about the hive and make direct physical contact with the other bees. This may be an exchange of pheromone, or some other exchange, but the physical contact definitely places the white blood cell and Queen amongst her own. So it must be with any consideration of reforming our political, legal, learning and cultural institutions.

We, as individuals in community - in common - need to be able to make regular and direct contact with everyone who aspires to hold public office, from a High Court judge to the council Garbo to the Vice Chancellor.

Political instruments, such as Citizens Initiative, Referenda and Recall (CIR), and also regular open and public forums to freely discuss policy direction are a start. So is petitioning the Crown over any issue. As is a pamphlet-letter-boxing campaign in your local area. Consideration of the **"Responsible Vote"** is long overdue. If we are to insist on accountability from our public servants, we must adhere to the same standard of accountability for ourselves.

Having an independent library or book club is important in that the sources of mis-information can be challenged back to substantiate fact from fiction from the MSM propaganda. Important works need to be collected as part of your re-education towards freedom.

### Summary

There is an area of commonality for traditional conservative people of all colours and persuasions. A place where labour, conservative, environmentalist and farmer meet. Where each can understand and support the other without totalitarianism. It is the local community. The place where power should reside, so decisions can be taken and results can be monitored and adjusted to suit local conditions. The further away from the local, especially towards national and global, the more difficult it becomes to achieve satisfactory solutions to issues. Resolution and Devolution, like the blood cells or the queen within a healthy hive. Not revolution and global governance run by remote unaccountable anarchists.
