WHO WILL COUNT THE VOTES, AND HOW ? By Arnis Luks

In my research for this week I watched several videos and read several documents and commentaries in regard to the election fraud that has occurred in the USA presidential election; in both electronic and mail-in ballots. Interestingly, just yesterday, in an entirely separate incident, I went to purchase some DVD covers across the Internet and I experienced something that aligned to what the USA fraud lawyers are suggesting occurred within their electronic voting systems. I made a purchase using my card using a reputable payment gateway. Interestingly the store that I purchased from also has an online auction presence. That each one of these entities is a deep-end player with robust internet financial security systems makes this story even more fantastic. The purchase was completed and I immediately received three emails. The first from the store - nothing new here. The second from the payment gateway - again nothing new here. The third email was in regard to what looked like a company of similar branding from where I had just purchased, with a request for a further payment through a direct bank transfer for the very items that I had just purchased. All this occurred in the blink of an eye.

When I was looking at the third invoice requesting a bank transfer of further funds I initially suspected fraud at the point of sale. Spending some time further considering what had just occurred I hypothesised that an internet interception was the most likely cause of the false invoice. In my mind this entirely unrelated incident reinforced what has been claimed had occurred in USA as part of the election fraud using the 'Dominion Voting Systems'.

The perpetrators don't stop just with election fraud, but saw other opportunities for financial gain, and have found interception access alongside modern secure and robust internet systems. Incredible, almost unbelievable you say. No negotiation, it happened. Just be careful out there.

A News item today reported of a hacked hedge fund that incurred losses of \$170 million. This immediately reminded me of the 2008 Beijing Olympics where a mirrored website appeared to sell tickets for the Olympics and was able to fraudulently acquire about \$20 million from ticket sales to an unsuspecting public.

Cybercrime is becoming more sophisticated by the day because the rewards are so great. This puts an end to any realistic justification for a cashless society - mandatory electronic monetary transactions. The satisfactory level of confidence required cannot be maintained. There is an elevated element of risk that may be unacceptable for some. I will continue to make internet purchases but with a heightened awareness of personal security.

These incidents place a very big question over all elections in every country. Could this demonstration of cybercrime in USA suggest that the level of interference, not only for financial attractions, but for any secure connection including elections, federal and state cabinet meetings, military communications, confidential business meetings, video conference meetings - the list goes on *ad infinitum* - be looked at in a different light.

If American Elections Can be Subverted, What of Our Own?

New Zealand and Queensland elections have just occurred. Earlier this year local government elections in Victoria and Queensland have also been held.

I remember reading of the 1982 Soviet military intercepting Argentinian communications during the Falkland Islands war. The level of sophistication was such that the interception was done in real time, intercepted, transposed and retransmitted. All in a heartbeat to change the meaning of the original coded military transmission.

For Your Information:

It is thought that there might be up to 60 billion barrels (9.5 km³) of oil under the sea bed surrounding the Falkland Islands. Drilling for oil in the vicinity of the Falklands began in the first half of 2010, sparking strong protest from the Argentine government. British financial interests were not prepared to let this valuable asset go even though the Islands are off the coast of Argentina.

I am certainly suspicious of both Queensland and New Zealand elections, and especially in light of the Sidney Powell court allegations directed towards the systemic electronic and mail-in fraud of the presidential election across key swing-states of the United States by both, CIA and CCP state actors.

James Ashby Lashes Media Monopoly

In a verbal spray directed towards the closing down of local print and radio media outlets, James Ashby (PHON) lays it on the line to why local media is so important - from 3:30:40 onwards. Surely this is an opportunity for an aspiring political and cultural voice to take up the cudgels themselves as the voice of reason, instead of in

particular the ABC bias. James Ashby was instrumental in introducing social media as the alternative media into One Nation for everyday use. I view the higher profile given to Pauline by the MSM may have caused that once active group to lose some of their hunger for an effective presence in this department. Promoting an independent and local media voice for every community, especially in north Queensland may be just the remedy to cover a multitude of main stream media sins.

I cannot help but comment that any movement if it is to be successful and not fall into the 'power racket' must be based on service. Eric Butler stood for election as National Director every two years without fail. He continued on until a younger person was in position to take over and he then stood aside. Postal Votes

Another point James Ashby does make during the telecast is the report of 30+% of disallowed postal votes due to only one signature on the outside envelope. I wonder if these one signature ballots 'just appeared', but scrutineers managed to pick up just in time. Similar situations of singular signature postal ballots occurred in USA to the tune of hundreds of thousands being accepted by election officials for some most important swing states.

Building on from that point, at 3:07:00 National Sen. Susan McDonald reinforces the postal anomalies adding that 50% of postal votes arrived late or not at all, blaming Australia Post. The local post office management takes on heightened significance at critical times like this.

The *modus operandi* is there if you take the time to look and compare these systemic election anomalies.

Other Elections

I hope those across the Tasman will put the necessary investigative energy into what did or did not occur in NZ.

MP Ms Fiona Simpson (LNP Maroochydore Qld) in the same Peta Credlin Sky News interview, mentions that local government elections held in March this year were a systemic train-wreck due to Chinese based coders. Preferential Voting - Thoughts

INQUIRY INTO 1998 FEDERAL ELECTION

The *Weekend Australian* (23-24/1/99) carried an advertisement from the Joint Standing Committee on Electoral Matters in the Federal Parliament, asking for submissions on the 1998 Federal Election. We know what one commentator felt, and believe his sentiments

would be shared by tens of thousands of others.

John Carter, writing a column "Counterpoint" in *The Land* (5/11/98), included these remarks:

In 1996 a Queensland woman was elected to Federal Parliament as an Independent. She made a maiden speech that included nine bipartisan issues not meant to be discussed in front of the people... The establishment decided to remove the irritant. As a former head of multi-national communications company wrote in *The Sydney Morning Herald* (5/97): 'Don't agree with any of the plausible things she says - just shout racism' - and it was so.

A political party was formed round her and the Queensland election result was a serious shock to the establishment. The person who had spoken the thoughts of 33% of Queenslanders had to be got rid of. The Electoral Commission altered the boundaries of her electorate. Polling continued to favour her party. The media settled into a biased assault of ridicule and personal abuse that has not been seen in this country in my lifetime. It didn't work. The major parties swapped preferences to keep the barbarians outside the billion-dollar building. The polls still showed trouble. Then, silently, the master-stroke was played. On July 17 the Electoral Act was quietly altered to bring in compulsory preferential voting. The major parties (in collusion-ed) had to be voted for - whether one liked it or not - and they all had One Nation at the bottom of their ticket. The media said, and still says, nothing.

This is how a woman who led the primary vote in her seat by miles and would have been easily elected in NSW, Queensland, UK, the US or South Africa, was removed from office. This is how a party with few resources got 8.5 pc of Australia's vote, but nobody into the House of Representatives, while the National Party got 5.3 pc of Australia's vote and 14 seats.

Preferential voting was originally introduced as a means for a voter to indicate whether there was more than one of the listed candidates whom he or she would opt for. For the principle to work it HAS to be voluntary. To compel voters to list preferences they DON'T LIKE is a violent attack on freedom of choice. To make the hundreds of thousands of voters looking for a way to express their disapproval of the major parties ultimately vote for the object of their disapproval is a cynical attack on the democratic process.

Queensland has in place full preferential voting - ed.

Irredeemable Debt continued...

The Victorian debt levels are projected to increase 250% with their latest budget spend - blamed on COVID-19. This will bankrupt that state if the funds are not sourced from their own financial institutions as debt free credit. The funds are a ticket system to work - that is all. Funds are not precious gems, but electronic and plastic measurement tools. The funds could just as readily be in the form of **tally sticks, shells or bottles of rum**. The state asset sell-offs have continued unabated for 20 years. The cupboard is bare. Along with massively increased debt levels of the other states and our federal government, this will allow the merchants (issuers of this intangible credit) unfettered access to what is left of our natural resources as a consequence of 'Debt for Equity Swaps' similar to what occurred to Greece 2007-2008.

If we do not look at this question of credit creation and our own manufacturing/industrial base and holding onto our own physical resources we will never get out of this muddle. We have come together and achieved great things before. It is within our genes to do this again. Steam power, in Europe alone, increased a hundredfold between 1800 and 1900 (*Encyclopedia Britannica, 1961, vii, 259*). Logically, the living standard of the average citizen should have risen steadily and massively from such an increase in real productive power, but the century was in fact one of widespread poverty, war and revolution.

By the end of the second world war, Australia was able to provide all our industrial and manufacturing needs including the war effort without huge imports. We completed the first world war debt free. Alongside manufacturing was our own aircraft industry. We have gone backwards by deliberate acts of successive governments of all persuasions. The LIMA agreement may have been originally endorsed under Whitlam but every successive government since has continued with the same policy. Political will to change this is lacking.

Our Restructured Government:

a Public Private Partnership

Public-private partnerships are a marriage between business and government, bringing businesses (desiring the protection offered by government's 'legalized force') together with government-agents that want the power offered by economic control. The newly formed National Cabinet avoids "parliamentary scrutiny of the Executive", being members from different parliaments and public and private entities, so being able to implement preferential policy with the full force of law. Victorian police 'force' is not the exception but rather the rule - fascist (corporate) rule. Masks, tests and vaccines under the police state.

Vaccines

The Australian government's National Immunization Program, like for all member countries of the World Health Organisation (WHO), is recommended by the Global Alliance for Vaccines and Immunisation (GAVI). This is a partnership with the WHO and UNICEF that includes the World Bank, the International Monetary Fund, the International Federation of Pharmaceutical Manufacturers and Associations (IFPMA), the Bill and Melinda Gates Foundation (BMGF), the Rockefeller Foundation, the United Nations Development Fund (UNDF) and other private research institutions. All members of this public-private partnership influence the development of WHO global health policies.

Upholding Our Commonwealth Constitution

Our Commonwealth Constitution is a 'limiting' document. It sets the boundaries of our federal government in relation to the states. It has been subverted by decisions of High Court Judges and now our politicians of all persuasions and at all levels.

It is being ignored by the current parliaments with the new 'National Cabinet' structure. All sitting politicians need to be pulled back into line to observe the Constitution. The Executives from all our parliaments must be answerable to their respective Parliaments.

Australia has been in a cultural and economic war for a very long time. Communities are only now just beginning to realize our nation has been de-constructed and handed over to international finance as their asset.

Policy and Outcomes

All major parties are playing from the same script. One group promoting predatory confiscation of our national assets and resources into private international hands through trade monopolies utilising debt finance.

The other group promotes similar collectivist policy of these very same assets and resources, but under state control, and then allow full and unfettered exploitation by the same private international financial hands. The courts in USA are hearing first hand of the collusion between the capitalist (CIA) and communist (CCP) political systems with the election vote rigging.
