Amongst the prisoners of war in Japanese hands were Gunners NX36861 William (Bill) Thomas Palmer and NX36853 William (Bill) Edwin Dircks.

Although the Japanese had surrendered on 15 August 1945, news did not reach the jungle camps until 6.00pm on 18 August 1945. At reveille on the morning of 19 August this flag was flying on a flagpole, complete with yardarms and halyards much to the surprise of the camp and especially the Japanese.

The material the prisoners used for the blue of the flag's ground was taken from the bottom of a Japanese mosquito net, which had a wide band of about 18 inches of blue material around it, the red came from the lining of a Dutch straw hat, blue in the Union Jack was obtained from an army signal flag, which was being used as a patch on a prisoner's shirt, and the white material came from the only known silk handkerchief in the compound. For thread the two men unpicked pieces of canvas from an old army kit bag. The whole of the stitching was done with wire needles, ground to a point at one end, and an eye punched in the other end with a bamboo spike.

The flag was almost finished at about 3.00am, working by improvised lamps using coconut oil when Bill Palmer and a couple of friends decided to spend the remainder of the night in erecting a flag pole made from the largest and straightest piece of bamboo available (about 40 feet long and 6 inches through the butt). Bill Dircks with another couple of friends, continued on with the making of the flag.

OPINION MAKERS By Arnis Luks

A recent addition to our online PDF library includes several titles by Ivor Benson. Of particular interest to us is his title "The Opinion Makers", very timely indeed. Benson has compiled multiple articles during the course of his journalistic career of where he concentrates on censorship and propaganda by the MSM. We can witness this same inordinate bias and censorship by the Main Stream Media in the News reporting of today.

The current news cycle is presenting a barrage of articles about a COVID-19 vaccine, time-lines and choices. What is lacking from the barrage of the MSM point of view, is the opportunity of discussion towards alternatives

to vaccines to manage immune stimulation vs the coercive powers of governments, industry and the MSM acting in concert by denying the exercise of freedom of choice for other options, and freedom of movement.

The current epidemic of autism spectrum disorder - perhaps as high as one in four of young males, attributed by many medical investigators to the ingredients within vaccines, sees the medical fraternity doing little investigation for causation, - treatment yes a plenty, causation almost nill. Some parents are delaying vaccination to the very last to avoid losing the government bribe-payment, or alternatively forgoing the payment to protect their children from the ingredients thiomersal and formaldehyde. Rockefeller was a monopolist and by establishing a medical training facility with the purpose of training the doctors of the future to market products created from the same industry he held a vested interest with which caused a narrowing of institutional education options available to 'manage health' in China from that time onwards.

An objective of most marketing campaigns is to increase market share. This makes sense if the sole objective is to make profits. If the objective is to provide permanent solutions (to maintain health and vitality), then this may produce an entirely different set of options.

To treat the symptoms of a common cold under the discipline of increasing market share, requires an ever-expanding plethora of products, each relieving different symptoms. To provide a permanent solution against the common cold may require a seasonal diet of garlic, honey, onion and 'high content vitamin A, D & C vegetables and fruits - of naturally occurring antibiotics and antioxidants, under an umbrella of regular outside activities - fresh air, sunshine and exposure to a wide variety of micro-flora.

You can see from the different methods for treatment entirely different marketing strategies. The first

requiring significant psychological manipulation, with counter-marketing against any alternative methods. The other - self managed health, requires a trip to the local greengrocer to make some sensible selections and ensuring time spent outdoors in the natural environment.

Community Diversity

Many and varied solutions are important to counter any dominating bias. The more varied the options available, the greater chance each person can find a solution that suits themselves. With only one option available or promoted, a significant vitality is removed from the community. Societal thinking will stagnate (dumbed down) at that point and take what it can get.

Classical Education and Action

The discipline of grammar, logic and rhetoric has been used from antiquity to approach any subject for learning. Health is no different. The voices of the herbalist, naturopath or dietician are given no airworthiness under the censorship of the MSM. Yet each of these disciplines provides historically and scientifically substantiated methods to manage health and vitality.

In regard to a realistic discussion around COVID-19 we can place this same template of classical educational and thought. Should the vaccine promoters be the only voice within the discussions and headlines of the MSM? Or should there be a variety of input from many sources so that an informed public - point and counterpoint - can make lifestyle choices that suit themselves?

It is that simple and really important to maintain the vitality of a community by listening to other diverse points of view.
