

Soul Searching for the American People

US President Joe Biden officially won Arizona by about 10,000 votes, <u>but</u> 23,000 <u>voters</u> had moved house, 10,000 potentially <u>voted in multiple counties</u>, 9,000 extra ballots appeared that were <u>not officially sent</u>. So there were at least four times as many dubious votes as Biden's theoretical victory margin. Bigger and possibly quite a lot worse than this was that: the Election Management Database and Files were deleted, subpoenaed equipment was withheld, and some logs were not preserved. The chain of custody was broken and machines (Dominion Voting Systems) that weren't meant to be connected to the internet, <u>were connected</u>. It's not that the US doesn't have free and fair elections, but that it's not even trying.

USA voters were defrauded of their rightful President. For most third world and communist nations voting is of little or no consequence. Voter fraud is problematic across all nations. The Maricopa County Audit "findings" offer no permanent solution to the fraud. It is simply – use the same voting computer-based system and we will put in place some more computer-based safeguards. Is there a realistic solution to state tyranny? Why is philosophy so important? What of voter fraud?

With the establishment of political parties, the debates have moved from the Parliament where they were recorded, to the privacy of the party room - party room debates are held in private, not open to public scrutiny. The surveillance state is fully immersed within secrets not open for public scrutiny. Public servants were historically held to account by the parliament, but this is rarely the case. They, the public servants, are insisting that they are now the new public masters. Stating the obvious may appear simplistic, but it's important to build a case of where we have gone wrong so far. Through taxation the bureaucracy and politicians are meant to be working for us: the voting and taxpaying public. Through never ending legislation, has allowed the bureaucracy unnecessary and comprehensive control over us.

I came across a booklet titled *The Christian and Modern Society* from our website under author Ted Rock. Lesson one summarises that: we either build up from the

individual, or we build down from dominating 'others'.

Christianity purports that <u>the state only has legitimacy</u> <u>when serving the individual</u>. Darwinistic-Humanism purports the opposite – the state as absolute. Which is correct: <u>is the individual to be served by the state</u>, or <u>is the state to be all pervasive over every individual?</u> Philosophy is important if we are to answer this question with a view towards our ancient freedoms. Should there be freedom of choice to use the mRNA injection or not? This could be a life changing, even a life and death decision. The mass medication decision of this experimental injection regardless of the consequences to life and liberty, is an act of belligerent tyranny by a totalitarian regime. Representation, similar to the United Nations, the European Union, and National Cabinet, is <u>unanswerable to the people</u> with administration operating predominantly in secret by the managerial branch. This is deliberate to thwart the will of the people. Our third tier of government, being local government, is effectively 'no more'. It is lost and must be regained if we are to make any headway whatsoever towards freedom. This Local Government Act 2020, with 'timelines' and 'targets' being set by legislation, has hamstrung and representationally strangled councillors. Would Jeff Kennet have foreseen this massive intrusion? **Potential Within the Individual Candidate**

Within the next 12 months some states will be called to elections three times. Being possibly the last effective elections we may have, places the local council elections in the foreground of freedom. Any freedom movement if it is to have any sort of lasting effect must come from a groundswell of public opinion - usually to the negative.
