# THE BARBARIANS WITHIN THE GATES by Eric D. Butler OnTarget 21 April 1995

During the past Easter Season (1995-ed) we have seen earnest and well-meaning Christians seeking in various ways, including street walks and open air services, to attempt to bear witness to their Christian Faith against what is often described as "the gross Materialisms" now dominating so much of man's life. The reality is, of course, that what could once be described as a Western Christian Civilisation, with its roots deep in the Greco-Roman Civilisation, now lies in almost complete ruins.

A feature of every dying Civilisation is that the great majority do not even know that it is dying. How can we expect the products of a secular humanist training system, misnamed as an education system, to understand that a Christian Civilisation is dying when they know little or nothing about that Civilisation, or how it grew out of a revelation which over time completely transformed man's relationship to government, to art, to every aspect of man's activities.

What was once described as a "liberal education", a term generally used before the First World War, was designed to produce what was called a "Christian gentleman", one with a broad knowledge of history, philosophy and the arts. Modern education is increasingly designed to produce what might be described as "technical barbarians" who can be slotted in to some narrow specialist activity in what is euphemistically described as "the work force".

The policy of "full employment" rather than self-employment is used to drive mothers from the home and to deny them their most creative role, the nurturing of the future generations of the nation. The basic tragedy of the situation is that the well-meaning, appalled by the growing violence, the sheer vulgarity of events such as the recent display of Her Majesty the Queen and Prince Phillip as nudes on a Canberra park bench, or a New York publication depicting a business-suited Easter Bunny crucified on a taxation form, fail to attempt to come to grips with the basic evil threatening Civilisation.

The author of Social Credit, C.H. Douglas, related the comment of one Christian theologian, who said that many of the better publicised sins of man were but like pimples on the skin compared with ultimate sin: the robbing of the individual of his most divine attribute, creative initiative, by the use of centralised power, thus driving him down the scale of life.

The philosophy under-girding the modern mass production system, imposed by a financial system, which generates increasing debt, is blatantly anti-Christian with its insistence that the individual exists to serve the system. Christ insisted that 'the Sabbath was made for man, not man for the Sabbath'. It is true that a spiritual revival is urgently called for, but such a revival can only take place when the individual is genuinely free and secure. Christ, the Son of God, claimed that He had come that man might enjoy the life more abundant. He taught that man should pray that God's will be done on earth as it was in heaven, and that God the Father should make

available the bread, the physical basis of life.

One of the central features of the Christian revelation is the stress on the importance of love. The practical application of the doctrine of love produces a specific Christian culture. But how in today's world can such a culture be sustained when every child is taught that the main aim in life is to be highly successful in competitive living, that his value can only be measured in his survival value in the struggle for power.

Christopher Skase (the Australian who was pursued internationally after his business empire financially collapsed-ed) is of no more value than a humble tradesman building a house. A sick society does need ambulance workers, but well-meaning and basically decent people can exhaust themselves in never ending ambulance demands unless they devote some of their energies towards grappling with that evil which produced the Crucifixion. Christian Civilisation is being crucified by the policies of the Anti-Christ. The resurrection of that Civilisation requires that professing Christians carefully heed the warning that Faith without works is Death. The modern barbarians have long since breached the walls protecting Civilisation; they are now firmly established inside the gates, often invited in by those who should have inspired campaigns of resistance to keep them out.

It was during the first modern revolt against a Christian State, the French Revolution, that the term, "The treachery of the clerics" became widely known. It was the treachery of Judas, which preceded the Crucifixion. The resurrection of Christian Civilisation can only take place by facing the reality outlined by the great Aleksandr Solzhenitsyn, that there is spiritual wickedness in high places, and that it is futile to look for effective Christian leadership from those who have established themselves in those high places. \*\*\*

#### Where The Rubber Hits The Road

In order to hold some hope towards regaining the political initiative from our (would be) totalitarian masters, it's necessary to consider how things worked or could have worked best considering 'their circumstances' from the past, to consider the present where our heritage, our spiritual and cultural reserves find expression, and finally the future to set forth a policy objective that is realistic considering our own resources and the mounted forces against us. While the Westminster system of parliamentary government is in tatters, similar to the political times of Magna Carta, the institution of government warrants preservation while the tyranny is brought to order. What methods can be brought to bear to achieve a realistic policy of limited constitutional government within an active and vibrant democracy of rule <u>of</u>, <u>for</u> and <u>by</u> the people?

In 2010, the state government of Western Australia lifted the ban on GM canola, allowing for the commercial cultivation of this GM crop for the first time. As a result some farmers, including Steve Marsh's next door neighbour began growing GM canola. Subsequently 70% of Steve Marsh's farm was GMO contaminated and he lost his organic certification resulting in those premium sale-price-losses plus additional court costs against him of \$804,000 in his attempt to gain compensation for the original GMO contamination.

#### **Representative Government**

What does this mean and what does it entail? The voter hopes to achieve some form of effective representation in the parliament by electing a representative. That person's primary duty once elected then becomes to <u>represent</u> the will of that electorate in the parliament to the best of their ability. This 'will' of the electorate may not always be clear cut, improve things, good, or correct, but that is the road prepared to be travelled by aspiring candidates.

All good in theory, but in reality, political parties, lobbyists and pressure groups have all undermined this electoral perspective to the point that policy is derived from the highest bidder (of donations or whatever) to these political crime gangs. Visualising representative government and actual practical results on the ground are two entirely different perspectives. Representative government as a political expression of voter-power must come back towards the people if it is to be again realized as an effective political mechanism for representation. **In Retrospect** 

A suitable retrospective response could have been to regularly provide your representative with your 'written will' to ensure they are reliably informed. Another could have been to hold regular public meetings for which the representative is invited, to be held to account for their current and past performance and the electorate reliably informed of prospective legislation and 'intended' voting.

This Representative, <u>not delegate</u>, is a two-way street. The public meeting must be held for sure, being the forum to discuss and consider various matters within the electorate and also curly issues before parliament that require community consultation and further consideration, such as the introduction of GMO seed.

A hard and self incriminating question to ask is "Is the elector able to deal with the real political Truth and the ramifications of that Truth, or would they prefer to just watch the footy?" Should we just give up and hand power over to the least corrupt party? I think that is exactly what we have been doing for far too long and thus find ourselves in this predicament. We have already gone down that road many times and may be hoping for a different result. But is this a realistic perspective to have?

Have politicians demonstrated that they can be left alone without firm guidance to do the right thing by their electorate? Are <u>any</u> currently in parliament doing the right thing about freedom of (medical) choice, of movement, of thought and action within the law? George, Malcolm, Pauline, Jacqui, Clive or Bob. Pauline and Clive are murmuring about choices for medication while the jab deaths are climbing and the middle class is financially collapsing. They are not in the streets with or leading the demonstrators. Nearly all appear captured, confused and/or worst of all <u>comfortable</u>. Each step of the process of taking back political power requires a degree of electoral commitment, personal and educational development, and vigilance from the voter to put sufficient energy towards every opportunity for consultation. This process must work both ways for sure, not just from the representative towards the electorate, but from the voter in return to their representative. The rep doesn't know what the rep doesn't know.

It is said that 'political events will move people'. Is covid lockstep/lockdown a sufficient enough event to move 'sufficient enough' people to change direction while on the road to political tyranny? I think this is how 'we are managed' by the money-power, in that we are played like a fiddle just under that threshold of sufficient unmoveable numbers to make that trigger occur.

There is also the further issue of lobbyists gaining 'representative time' that may adversely effect outcomes for the electorate. What if - like SA Primary Industries Minister David Basham - the representative clearly goes against the will of their electorate, what then? What options do you and I possess to bring the recalcitrant politician back to order? A mechanism would need to be found to exert sufficient political pressure on the situation to overcome the lobbyists interests, to the point it becomes obvious-political-suicide to defy the will of the electorate any further. I realised watching this video that there is hope for the future providing there is sufficient <u>faith</u>, informed political <u>will</u> grounded within <u>action</u> in the field.

Eric presents the unfolding events around the 1988 federal government's intention to introduce an ID card, with the increasing community resistance finding expression in many, many political campaigns occurring behind the scenes. Some campaigns were educational, some were news disseminating, some were directly and specifically targeting against the existing representative. All were independently run; autonomous campaigns targeting specific electorates to unnerve or/and unseat the recalcitrant politician. Representation coming back to the people will only occur when the people themselves insist (by their actions) to take some of this political power back. Government, meaning politicians, political parties and the bureaucracy will never relinquish political power once seized.

The 'yellow vests' in the Paris streets have been demonstrating regularly each weekend for <u>3 years</u> with no change in results. The MSM are complicit with their heavy hand of censorship now rarely reporting on these public demonstrations of discontent. Other mechanisms must be sought, especially in the light of further potential lockstep/lockdowns under the covid ruse.

#### A Realistic Proposal - A Service Movement

A decentralised, autonomous, independent and selfreliant political-service-movement is in order, providing current and reliable news, public education, and support with guided action on the ground to assist each electoral community to regain some effective control of their representative. This has been performed successfully by left wing activist to unseat both Sophie Mirrabella (Indi) and Tony Abbott (Warringah). The left almost unseated Alexander Downer (Mayo) with the same strategy. The active left will continue while others sit on their hands. Can we learn from what the active left are doing? **Education** 

Province of Alberta, Canada successfully removed their provincial (state) government through a program of public education, focused predominantly around Douglas Social Credit - the Policy of Freedom. An informed public, with reliable News and Educational Information builds the community's Real Credit. Alberta had the then luxury of a Sunday evening radio broadcast and sufficient educational material to overcome a stubborn MSM. Political Education is a valid mechanism for freedom.

#### Local Political Campaigns

In Eric's video, he explains that in 1988 effective political campaigns were able to achieve a 30% change of voting patterns by reliably informing the public of what was actually going on with their rep & government. **The Vote**
