With the South Australian election campaign being completely overshadowed by media (propaganda) of the events in the Ukraine, we make the following observations: No political entity is campaigning against the loss of our ancient rights and freedoms. This method of having a nation-wide propaganda machine or campaign (to bring into existence an entity at the national level) is often repeated. France Emmanuel Macron did this very thing with central bank backing and WEF world young leaders training. Macron came from nowhere without a party behind him. Just a massive propaganda machine financed by central banks. He was not a groundswell choice from the people and has been actively resisted ever since by yellow vests, even today.

Our governmental apparatus will be 'subjected to significant influence' by the \$100 Million worth of clever advertising, on the basis that UAP makes more sense than the other lot. Their (UAP) propaganda certainly makes for attractive viewing until a deeper, considered-look is taken and the filter of 'self-interest' and 'inordinate influence' is shown to the light. One man holding the balance of power to govern an entire nation, and only answerable every 3 or 6 years. Clive as saviour, but more realistically potential king-maker of self-interest.

....Australia is faced with its fourth great challenge since
Federation. The first was the First World War when
Australia had to cope with severe military losses, bitter

divisions on the home front over the issue of conscription and social dislocation. The second was the Depression when up to one third of the workforce was unemployed. The third was the Second World War and in particular the threat of invasion from Japan, when a limited form of conscription was introduced, but not without rancour. These three great periods of stress and the responses to them have had an enormous influence on today's Australia. All three were clear cut and part of an international experience. Australia, on the world stage was one of the smaller players, but it was not helpless in the face of international forces and pressure. It could and

did make decisions to influence its own destiny and can

do so in the challenge it faces today.

The fourth challenge is also part of an international experience, which is far more difficult to recognise, let alone define, but its outcome has the potential to shape the country far more completely than any of the preceding three. Australia is faced with an inexorable economic and social decline to the status of a Third World colony unless it rises to this challenge.

In spite of the fact that this entails coming to terms with powerful international forces, the country's biggest battle will be won or lost at home. It will be fought between groups with two broadly conflicting views of how Australia should respond to these forces to secure its future and the skirmishes have already begun. One view can be described as basically nationalist and the other broadly internationalist.

Naturally both sides will attract extremists, but it is the moderates with coherent visions and a commitment to democracy who will determine the outcome. There will be no shortage of attempts however, given the examples of the recent past, to link the moderates, particularly the moderate nationalists, with the extremists...

Oligarchs within Russia and China

What is Mass Formation Psychosis?

Psychosis of any kind is when a person loses some contact with reality. Mass formation psychosis is when a large part of a society focuses its attention to a leader(s) or a series of events and their attention focuses on one small point or issue. Followers can be hypnotized and be led anywhere, regardless of information proving otherwise. A key aspect of the phenomena is that the people they identify (with) as the leaders – the one's that can solve the problem or issue alone – they will follow that leader(s) regardless of any new information or data. Furthermore, anybody who questions the leader's narrative are attacked and disregarded.

There are four key components needed to bring into being mass formation psychosis:

- lack of social bonds or decoupling of societal connections, (1960s-70s onward hippy/freedom movement, deconstruction of our history, cultural achievements, our Christian religion)
- lack of sense-making (things don't make sense cognitive dissonance, constant propaganda)
- free-floating anxiety, and free-floating psychological discontent. Free-floating anxiety is a general sense of uneasiness that is not tied to any particular object or specific situation or event (climate, covid, 9/11, millennium bug, weapons of mass destruction, Ukraine war, Armageddon)
- When followers start to participate in a strategy to deal with the object of anxiety, new social bonds typically emerge, and people change from a highly aversive negative mental state and isolation, to the exact opposite to the extremely high-level of connectedness that exists (putting faith into one leader, saviour, dictator)

I personally witnessed, and many before me have written about, the subversion of our nation from the 1960s on, with the deliberate infiltration of communists into all our learning institutions, degrading of our culture through subversive 'leaders of influence' and perversion and subversion of our religious institutions and cultural achievements and self-worth beliefs. Building upon this is the seditious media constantly maintaining these levels of anxiety to usher in the great-reset world dictatorship.
