WHY THE INDIVIDUAL? By Arnis Luks

Why would the individual be so important that the law (Sabbath), and all institutions are made for their direct benefit - not as a mob, but as an individual person. I needed to turn to the Roman Church's *'Penny Catechism'*, referenced by Archbishop Hepworth to find the true answer. Every human being is a unique and eternal creation, (soul), never again to be repeated, having been given this life to come to know, love and serve God 'forever'. Humans are not created equal, but they are so created as to choose moral solutions and be responsible for the life lived - 'to him whom much is given, much is required'.

This business of 'loving God (in preference to all else) and serving Him' reinforces the requirement for sufficient freedom to do this. This sufficiency of freedom is sought through political policy – the abolition of slavery, the 40 hour week, public-hol(y)days and weekends. Loving God is firmly embraced internally (pondering the good – God, in preference to all others) and then externally (incarnating our internal faith (trust, hope and love) into works). The church's function is to emphasise this internal growth – to develop the soul which is eternal. Hence the need for those 'principles' being enunciated from the pulpit.

The placing of 40 new bills before our federal parliament is an aberration against this self-rule, causing individual abrogation of personal responsibility, preferenced towards the bureaucratically-planned and managed state. Puritanism would impose a legislated goodness over people while removing their freedom. Multiple Ministries Not Unprecedented

From the Record Books

Gough Whitlam, upon his election in December 1972, was sworn into 13 Ministry portfolios, with 14 Ministry portfolios by his deputy Lance Barnard, 27 Ministry's in total to only two people. To ensure there was no breach of propriety all Ministry decisions were made by the Federal Executive Council which has a quorum of three, including the Governor-General or their representative. Sir Paul Hasluck as Governor-General attended all meetings of the Federal Executive Council and participated in all decision-making and was thus effectively the third member of the first Whitlam government. https://www.naa.gov.au/explore-collection/australias-prime-ministers/gough-whitlam/during-office

Those Whitlam decisions made within this quorum of three, and others foreshadowed, included: the complete withdrawal of forces from Vietnam, the release of draft resisters, the removal of excise tax on wine, a ban on racially selected sporting teams, independence for Papua New Guinea, major grants for the arts and Aboriginal people, grants for Western Australia, Tasmania and South Australia, rice aid to Indonesia, the purchase of new F-111 planes, the appointment of Elizabeth Evatt to the Conciliation and Arbitration Commission, a judicial inquiry into Aboriginal land rights, the appointment of John Armstrong as High Commissioner to London, the opening of unpublished government reports, special assistance for Aboriginal education, new nursing home benefits, a reference to Australian suppliers in government purchasing, a commitment to the decentralisation of university locations and more Commonwealth funding of universities, a grant to clean up the Tamar River, new government representation at the International Labour Organisation (ILO), removal of the ban on the advertising of contraceptives, removal of sales tax on the contraceptive pill, new membership of the Commonwealth Grants Commission, the convening of an interim committee of the Australian Schools Commission, a new airline curfew for Sydney airport,

new benefits for permanent members of the armed forces, the appointment of 'Nugget' Coombs as an adviser to government, the commencement of talks on diplomatic recognition of China, reopening of the equal pay case, restoration of Wilfred Burchett's passport, instruction to TAA to lower fares, announced scrapping of the honours list, the closure of the Rhodesian Information Centre in Sydney, and the recalling of Australia's ambassadors to the United Nations, Washington and Taiwan.

Whitlam and Barnard, with Governor-General Paul
Hasluck as part of the Federal Executive Council,
approved 18 recommendations at meetings between 5
and 19 December 1972. These included: amendments
to various government regulations, the making of
ordinances, making various government appointments
including permanent heads of departments, the signing
of the International Covenant on Economic, Social
and Cultural Rights and the International Covenant on
Civil and Political Rights, and the abolition, merger
and establishment of government departments. One
journalist termed it 'rapid-decision government'...end

The imposition across the once-free-world of transnational-corporate policy through the UN-and-its-agencies has occurred progressively across the past 50+ years. The 1969 'Vienna Convention on the Law of Treaties' came into force in 1980, was in regard to nation-states and other interested parties within international law. Note that the Tasmanian Franklin Dam High Court decision occurred in 1983, three years later, giving massive new 'external affairs' powers to our federal government to enact treaties with foreign entities, circumventing our Limiting Constitution. Our activist High Court led the way to bring about this move towards corporate anarchy with this 4-3 Lionel Murphy-led-decision.

National governments are making many agreements, circumventing (evading) their limiting constitutions through the now privately financed (since 1990) United Nations, International Treaties, and Transnational Trade Agreements. Pakistan was sued through a tribunal (three private judges behind closed doors) of the World Bank's International Centre for Settlement of Investment Disputes (ICSID) by a transnational corporation whose entity is within Australia, but the parent company's,

Preface

As she basked in a landslide victory in the 1987 General Election that had followed a split in the opposition, albeit with only 42 per cent of the vote, Margaret Thatcher gave a rambling interview to *Woman's Own*. During it, she made and repeated the revealing remark that summed up her ideology. 'There is no such thing as society', she said, adding 'there are only individuals and families'.

One senses that she would have made no objection had the tense been changed so as to read:

'There should be no such thing as society.'

and was Ronald Reagan's too.

What lay behind the remark? When elected leader of the Conservative Party in 1975, at the first meeting of her Shadow Cabinet, she took out from her bag a copy of Friedrich August von Hayek's *The Constitution of Liberty* and slammed it on the table, saying, 'This is what we believe!' It must have crowded out other things, since it was a hefty tome of 576 pages. Hayek was Thatcher's guru

The Austrian economist had set up a mostly right-wing group of economists and other scholars as the Mont Pelerin Society in 1947. He was not a conservative in the traditional sense, but believed fervently in a 'free market' economy. His mentor was Ludwig von Mises, another Austrian. What von Mises taught Hayek, and what Thatcher digested, was that economic value was measured only by price; what had no price had no value. In the political hands of Thatcher and Reagan, this view was to evolve into a wholesale agenda of privatization — nothing less than the dismantling of public institutions and bodies that stood against market forces. And if something has no value, it can be given away for free or abolished or converted into something that does have value, a price. 'Thatcherism' cannot be understood without understanding Hayek and von Mises.

In 1976, Hayek was awarded the Nobel Prize in Economics, reflecting the capture of the mainstream economics profession by 'neo-liberalism'. In 1984, Thatcher arranged for Hayek to be given the rarely awarded Order of the Companion of Honour by the Queen, which Hayek described as the 'happiest day' in his life. He presumably did not see the irony that the monarchy was hardly a testament to a free-market economy.

Reagan said Hayek was one of the three people who most influenced him, and in 1991 George H.

W. Bush awarded him the US Presidential Medal of Freedom. Truly a prophet honoured in his lifetime.

Hayek's Mont Pelerin Society still meets regularly around the world and continues to influence mainstream economics. This book is about what is probably the most destructive aspect of the neoliberals' economic ideology. In their view society has no price and so has no value; therefore the institutions that make up society can be dismantled. For good measure, because only the market determines prices and value, anything that stands apart from or against the market is not just value-less but market-distorting.

Thus began a war — and no other word captures what has been involved so well — against all organizations and mechanisms of society embodying values of social solidarity, which have no price. The war has been conducted most vehemently and incessantly against what historically has been known as the commons. The commons has a lovely ancestry, as this book tries to remind us. But it is also vital today.... end

I listen to quite a few differing voices of how to approach our impending doom. I cannot move away from the wisdom of the Eric Butler's and Geoffrey Dobbs' of this world. They have looked to the true nature of man and recognised the innate weakness that corrupts absolutely - 'lead us not into temptation'. The natural law; the Canon cannot be circumvented. Gravity will always pull us back to earth; excessive power always leads towards corruption. Being responsible for your own life is unavoidable. Handing this decisionmaking to administrators will lead to a hell on earth as we can see more and more each day as power is further centralised. Christians have provided a genuine legacy of leadership towards freedom with responsibility in a moral environment. This is the natural law, the Canon. Accepting this cross as the True Guide to steer us out of this civilisational-collapse is the only hope for a recalcitrant world. God is our Saviour and our refuge which we ignore at our collective peril. At this critical point in our dilemma it is appropriate to take a moment for reflection, to seek the light of Truth as to how things have historically worked best. I turn to Christ!
