THE MOST DANGEROUS IDEA IN HUMAN HISTORY By Arnis Luks

Betty Luks wrote... I watched Mel Gibson's film version of *The Passion* this Good Friday, listened to The Hallelujah Chorus and was reminded of a Youtube discussion between Jordan B. Peterson and Iain McGilchrist. They were questioning why God allowed evil to exist in the world, followed by another question: "Taking into account human nature and the quality of living: do you make people safe or strong?" AJL.. Last week I mentioned the Communist origins of the establishment of the United Nations. I came across a booklet by David Thompson titled "The Human Rights Swindle" which further reinforced these origins and purpose of the UN.

We see these same levels of violence exercised at least twice last century across Europe, former Yugoslavia, the Middle East and Ukraine by the civilised West!

The stolen generation narrative presents an imbalanced perspective of the interaction between the two cultures. Without an appreciation of the traditional western family and the nomadic aboriginal tribal community, there can be no realistic assessment of the right nor wrong of each individual case where a child was accommodated. Part may have been based on the direct welfare interests of the child. Part may have been to more readily assimilate the child into Australian society. The question of blanket compensation is fraught with error and subliminally places collective guilt onto Australia's non-indigenous peoples with little appreciation of this cultural variation and unique circumstances for each child.

Money will not remedy the inconsistency between the nomadic aboriginal culture and the Western European culture, but as with any disadvantaged peoples, education and opportunity for personal development, whilst promoting assimilation to produce an homologous society will be of benefit for all.

Using the current Apartheid policy of maintaining separate development within the aboriginal missions, has done little or none, any good. This is the end objective; to deliberately hold the aboriginal down while also disenfranchising the non-aboriginal to set up a separate communist (called aboriginal, but brutally communist) nation within our borders. Eddy Mabo was not the exception to this communistic influence, but rather the rule as Geoff MacDonald has explained and substantiated by his written record *Red Over Black* and *The Evidence*. These High Court decisions - Franklin Dam 1983; Mabo 1992; Wik 1996; have each altered and weakened our constitutional arrangements to the detriment of all.

Both major political parties are committed to pursue this line of establishing a voice above parliament against an homologous people to align with world government policy. The Greens wishing to go even further. But who of so great a font of wisdom would sit in this elite chamber above government? Will this voice provide a better result, a better method of governing? This policy would promote a branch of unelected elites having sway over our already corrupted parliamentary system. Onevote one-value will therefore go out the window. The first consideration towards any view of climate has to be the observable world. Is the weather changing significantly, or is it still within normal parameters? Looking at this guest post on JoNova's website shows the solar cycle 25 (270 years of records) is running within historical parameters. No sunspot activity surprises here. If anything, the earth is cooling - slowly across the past 3 solar-cycles.

Motive, which is well past profit, is revealed within the pursuit of world power exercised through the public private partnerships called the United Nations and all UN's ancillaries. Without the propaganda of a climate emergency there is no justification for Agenda 21, Agenda 2030, the Great Reset, covid 19 or anything else. This is all about empire - world power by another name.

Carbon Sequestration

The pumping of CO² into 'no-longer-used-wells' for storage, or into oil producing wells to enhance oil recovery EOR (for refining) uses additional energy for the necessary infrastructure (with the production of further CO²). They receive a dual financial advantage; in the CO² pumping achieves a carbon-credit as also does the enhanced oil recovery EOR with increased oil production. A double win for some. Let us not go into nuclear as the end result is a toxic waste no one in their right mind wants to put into their own back yard.

The total CO² generated by this environmental model is increased in two distinct ways; by the extraction, refining, manufacture, transportation, installation, maintenance, decommissioning and remediation of power generation by CO² saving devices, and then the extraction, refining, manufacture, transportation, installation, maintenance, decommissioning and remediation of pumping equipment for CO² from high CO² emitters into the unused or EOR wells. This policy is pursued for financial gain, rather than let nature take its course with CO² sequestration into the soil by sustainable agricultural practices such as organics, biodynamics and permaculture farming practices.

In this climate model is the land of voodoo - hopes and wishes with no practical result. The total CO² produced during the full life cycle of this model is not readily scrutinised. A lot of papers but no raw data out in the open. A bit like the hockey stick of global warming fame - disproved in courts. Putin's policy of limiting fertiliser exports (another massive CO² producer) may cause a revival by our farmers towards organics, biodynamics and permaculture work practices instead of chemical fertilisers. In my view, this would not necessarily be a catastrophe. I have long held the view that the increasing CO² in the atmosphere is compounded by chemical farming practices more so than supposedly greenhouse gases. The loss of humus through chemical farming releases CO² from the soil. Don't dare point the bone at big-Ag or big-Pharma. People will believe anything provided it comes through the box.

Statistics are readily used to advance a cause. Power generation, for example costs a certain amount from each emitter. Solar and Wind receive a subsidy to manufacture power, but are only readily available for power generation 15% on average per 24 hour day. Increasing this equipment volume by 6 or 7 times will not alter that number as the sun only shines on one side of the earth at a time, and the wind may not blow at all for days. More fans and panels does not equate with more power unless you can factor in battery or hydro. Battery is prohibitive for round the clock supply, however hydro, although less

energy efficient <==>, but can be stored for later use, so the 6 or 7 multiple may be realistic. The extraction, refining, manufacture, transportation, installation, maintenance, decommissioning and remediation costs all come from the suffering public purse, and each stage causes further CO² emissions to take into account of the total CO² footprint. There is no snapshot answer to this environmental question, but must begin with 'where and how much' power needs to be supplied?

For a Prototype Think Local

Looking at solar to our home for instance: a set of panels, inverter with battery backup to cover cloud free days and nights may be more practical if some power circuits were taken completely off grid. This may be more energy-and-financially-efficient than sending unused power with a very low tariff back into the grid. Fridges, washing machines, hotplates and stoves used mostly during the day would make ideal circuits to consider to maximise return on investment. Just measuring across the meter is a biased calculation when splitting the circuits may be financially more viable. This model also provides a line of food security during power outages. Don't tell me that won't come - it is already on the way. Klaus is making sure of that and your governments (whatever persuasion) have both been running down power generation facilities for 20+ years.

Solar is only one consideration. I also have several generators in the shed to cover most short-term circumstances. I ran two during an extended power outage to cover food security and the internet/computers for broadcasting. It worked for 4-6 hours OK with extension leads. The limiting factor here is fuel (petrol = one tank = 9 hours running) and noise pollution during the running. For the long term I could direct exhaust gases into a water pit to muffle the noise. Let's be honest. The CO² emitted, is not a considered factor once the power supply goes off. Up till then this discussion is hypothetical and emissions will go out the window to ensure food security. If the sun doesn't shine and the wind doesn't blow I still need power to ensure

continuity of supply to protect my food storage.

'Under The Rubble' shows that even in our political 'system of lies' which we are especially experiencing this past two years; spiritual regeneration can occur when enough determined individuals who are prepared to forgo their own desires and overcome adversities for a greater calling. The necessary regeneration of our political institutions must begin with self.

Peter Hitchens deduced the most dangerous idea ever expressed was of the resurrection. The individual must then accept their own rebirth after 'death of self'. This revelation of truth is sufficient to change the world.

UAP Clive Palmer's proposal to place a tariff onto iron ore is short sighted. This policy responds to the fact Australia has a debt problem from which it is having difficulty extricating itself. This tariff places that burden of debt onto the importing nations. China has recently increased import tariffs of 107-200% to our \$1.2B wine industry: that two can easily play that game should it suit. The Trans Pacific Partnership trade agreement will also have something to say about their industry losses being adjudicated through world trade courts. This will not end well for Australia as sanctions against Russia have recently demonstrated, nor resolve the issue of irredeemable debt caused by the fraudulent financial system. UAP and all other political parties will never get to the root of the fraudulent financial system since each relies on the banks, as that power, that each bends their knee to. Our Constitution gives the authority to the Federal Government for financial matters 'except state banking'. The states would do well, now that COAG has been disbanded in favour of the National Cabinet, to initiate their own state bank as was prior to the deliberate bankrupting of each state bank to remove self reliance one further step away from the Australian people. These things do not occur by accident. They all occurred as an integral part of long term planning towards world government: as bipartisan party policy to the great reset. **BASIC FUND** - To all supporters.
