### DISCERNING TRUTH FROM FICTION: AN INTELLIGENCE REPORT By Arnis Luks

AJL...Inflation Reports are finally surfacing. OT writers reported on this perhaps a year ago as a consequence of repetitive lockstep/lockdowns (collapsing industrial production) and massive increases in government and personal borrowings - spending power issued to the community without any corresponding expansion of the productive system. This week I read three differing articles in regard to 'managing' inflation by economists and theoreticians. None of those articles deal with the fundamental issues, even though mentioned, of the centralising of new

credits as debt behold to central banks, nor the de-industrialisation of the West by adherence to the Lima Agreement. CH Douglas presented the case that what is physically possible must be made financially possible. The financial system (being a man-made system) can be so adjusted to reflect the physical reality of the modern mass-production age. Debt is not a natural occurrence. We cannot naturally expend (spend) tomorrow's seed before the crop is planted and subsequently harvested. But we certainly can deplete our inheritance by denuding the soil of its life-giving forces, as we also can our culture.

### **Technological Advancements**

Less than 5%, perhaps as low as 3% of the population are now required with the modern computerised and automated industrial processing systems to produce all our food requirements. Before the Industrial Revolution that number was around 85% of the working population including women and children. Food and water are both essential for life. Yet, there are reports of an imminent supply chain collapse resulting in significant hardship, if not outright famine. This planned event is to ensure compliance to the communist inspired world government, or the New World order, or the great reset, or agenda 2030, or net zero emissions; take your pick.

The imposition of this policy of world government is directed against every person on the planet. It is a war of power; nothing more. Food, as is already done in North Korea, will be limited or rationed to compel all people into submission. The recent Government issued lockstep/lockdown money (on the never never) was utilised in Australia to do exactly that, enforce compliance and equally "reliance" during the past two years of covid. Have you prepared for this upcoming planned famine?

The world government's most pervasive tool apart from the centralised financial system, is constant brainwashing through the monopolised media - press, platform and pulpit. Unsurprisingly, the Church of England plans to establish a shadow government to assimilate into this new world structure. They have forgotten their commission to bring the good news; the Gospel to the world. This commission is being replaced with a gospel of covid, climate and power over the whole world of which they are very much a part.

Guy Standing, who previously wrote *The Precariat*, has now produced *Plunder of the Commons - A Manifesto for Sharing Public Wealth* after having also written *Basic Income: And How We Can Make It Happen*. *Plunder of the Commons* is Guy Standing's justification to provide a 'manifesto' to update the Great Charter of the Forest. This Great Charter of the Forest being what was omitted from the Magna Carta across the 1215 and 1225 versions. Guy Standing's assessment of Austrian neo-liberalism, better called Libertarianism is consistent with my own.

Neo-liberalism or Libertarianism was founded upon Frederick August von Hayek's *The Constitution of*

*Liberty* becoming the template, or *modus operandi* for the Mont Pelerin Society established 1947, believing fervently in a 'free market' economy. Hayek's mentor was Ludwik von Mises. Both neo-liberalism and Marxist/Leninism are taught along side each other at the London School of Economics and Science.

Thatcher-ism and Reagan-ism cannot be understood without understanding both Hayek and von Mises with their wholesale agenda of dismantling public institutions towards privatisation. Guy Standing counters with his thesis towards establishing a new Charter of the Commons as the natural progression from the (great charter) Magna Carta and the Charter of the Forest.

While his effort is admirable, he fails to answer how to effectively distribute or transfer the fruit of production (created within the modern computerised and automated industrial processes) to the common man - distribution. By once again opening up the Common land, individuals are not necessarily lifted out of subsistence living, however beneficial that type of lifestyle may be. CH Douglas proposal is of reconciling the fruit of modern industrial processes being the rightful inheritance of every person. The true purpose of production is consumption via an equitable method of distribution - the National Dividend. With the issue of a National Dividend (as sufficient spending power to reconcile the costs associated with production), this decentralising initiative restores the fruits of the earth as sustenance for all.

The 3-5% of the working population needed to produce all our food, will still be rewarded in full with their wages, but also receive their share of the cultural inheritance as a National Dividend. Just as the owner of the land, machinery and technology to produce this sufficiency will also receive in the form of a just price, sufficient financial return on their efforts to liquidate costs and some profit.

CH Douglas's proposal scientifically balances the budget, or reconciles between costs, prices and available spending power (distribution) within the community.

Within modern banking practices, all new money comes into existence (created out of nothing) as a debt to the banks – when new credits should actually come into existence as a dividend. Would you expect your accountant to claim all your assets as their own simply for doing the books? Neither should the banks. This fraud has continued into the modern era - 1694 with the establishment of the Bank of England following the Bank of Amsterdam (Amsterdamsche Wisselbank) 1609.

A Wikipedia article makes for enlightening reading : ...The foundation of the Dutch East India Company (VOC), the world's first publicly listed company and the first historical model of the multinational corporation (or transnational corporation) in its modern sense, was in 1602. Historically, the VOC played a crucial role in the rise of corporate-led globalization, corporate identity, corporate governance, corporate finance, and corporate

capitalism. The birth of the VOC is often considered by many to be the official beginning of corporate-led globalization with the rise of modern corporations (multinational corporations in particular) as a highly significant socio-political-economic force that affects human lives in every corner of the world today...end

The transfer from Amsterdam of this centre of banking/industrial monopoly to the City of London and later again to Wall Street consolidated the multinational corporate-bankers grip over the world.

The counter to central bank domination is to provide sufficient spending power be placed into the hands of each individual to provide access to the means of sustenance –the fruit of the modern production processes.

The National Credit Authority, as the issuer of new credits in the form of the dividend, reconciles the historic disparity between the wage earner and the capitalist by balancing the financial system with the economic system in the form of an adequate method of distribution. This is the counter to monopoly capitalism and socialistic communism. The social responsibility of mass production is reconciled with a personal dividend for all.

Centralised Bank control of the financial system over the entire planet must be reorientated, devolved or reset back to the national and state/provincial level, but also separate from and above government. Governments have demonstrated that they cannot be trusted with excessive power, so the National Credit Authority as a commission must operate separately from government and be open to public scrutiny to ensure compliance and accountability.

During the last world war, Australia utilised a "consumer price discount" to offset inflationary pressures. With the continuous evolution of modern technology and efficiencies, the real cost of production will continue to fall and should correctly be reflected at the marketplace with falling prices. The shortening of supply of available produce effects the selling price. We have seen this with the Murray Darling Basin Authority limiting available water, or local government limiting available land for home-building, and we now see it with wholesale electricity prices soaring 141% year-on-year.

The perceived shortage of natural gas across the world, and the deliberate shorting of available power generation capacity with the green agenda, is directly affecting the price of electricity. CO<sup>2</sup> is not the threat nor culprit that the IPCC makes it out to be, but this perceived threat is necessary in order for the IPCC to justify their existence as the world authority as part of world government. Fauci, Gates and the WHO operate similarly.

### Summary by Lord Acton

Lord Acton wrote to Bishop Creighton (1887) in a series of letters concerning the moral problem of writing history about the Inquisition. Acton believed that the same moral standards should be applied to all men, political and religious leaders included, especially since, in his famous phrase, "power tends to corrupt and absolute power corrupts absolutely": **ACTON:** I cannot accept your canon that we are to judge Pope and King unlike other men, with a favourable presumption that they did no wrong. If there is any presumption it is the other way against holders of power, increasing as the power increases. Historic responsibility has to make up for the want of legal responsibility. Power tends to corrupt and absolute power corrupts absolutely. Great men are almost always bad men, even when they exercise influence and not authority: still more when you superadd the tendency or the certainty of corruption by authority. There is no worse heresy than that the office sanctifies the holder of it. That is the point at which the negation of Catholicism and the negation of Liberalism meet and keep high festival, and the end learns to justify the means. You would hang a man of no position, like Ravillac; but if what one hears is true, then Elizabeth asked the gaoler to murder Mary, and William III ordered his Scots minister to extirpate a clan. Here are the greater names coupled with the greater crimes. You would spare these criminals, for some mysterious reason. I would hang them, higher than Haman, for reasons of quite obvious justice; still more, still higher, for the sake of historical science...**end**

### Action Plan from the ND's Desk

Are you ready for a Digital Identification system? Who is it that will be watching your activities? Plans around the world are being set for the introduction of a digital ID system. It is being promoted as a smart way to prove your identity which may be required for social security, business deals, taxation, travel, licences, or even current medical status.

It is understood that Australia has already prepared for the scheme to be introduced.

If this is such a beneficial scheme, will there be any downsides and from where did the idea emanate? On the positive side, it will provide a quick and easy way to prove your identity but it will also permit surveillance of every move you make because it will inevitably be linked to credit card activity and your carbon footprint. While you may feel it will not matter if no mischief is undertaken; most people cherish their privacy and don't particularly want others peering into their daily life. The idea of surveillance and digital ID has no doubt been around for some time; however the current promotion has its origin in the World Economic Forum (WEF) which is a group of elite unelected world leaders who meet regularly at the city of Davos, Switzerland. Their publicised aim is to create a World Government, sometimes known as the Great Reset (no doubt run by them) where complete centralised control of every person would exist and national boundaries would no longer have a need. Mechanisms would need to be implemented to achieve total control over the population and the digital ID is seen as an important part of this surveillance mechanism, as is the proposed central bank digital currency. WEF has stated, "digital identity," would offer globalist politicians in every corner of the world the resources they need to track citizens' movements, their financial spend and their carbon footprint.

The scheme would likely begin with the appeal of a seamless, safe and secure way of proving identity. Australians are generally unaware of the surveillance state agenda and if the Coalition has successfully prepared the groundwork for it, the next Parliament will be keen to advance the programme. With an ALP Government, it will be difficult for a Coalition Opposition to oppose something previously developed by themselves. And with a Coalition Government it will still be full speed ahead. The one means of defeating this agenda is for candidates to make a firm, written commitment against supporting any form of digital ID system prior to the May election. If they cannot commit then they cannot be supported, in fact must be actively opposed.
