BUILDING BLOCKS TOWARDS TYRANNY By Arnis Luks

Collaboration of the Political Parties

In 1975 the Victorian Liberal (Rupert) Hamer government was making steady moves through both houses of the Victorian Parliament to implement an entirely revamped Victorian Constitution Act. This revamped Constitution Act 1975 upended the relationship of balanced powers between the lower house, upper house and the governor of Victoria. In fact, it changed the balancing-relationship of this triune parliament to one of domination by the legislative assembly, the lower house. The timeline of passage is most revealing.

The gazetted 'proclamation' of this Constitutional Act, not by a popular vote from the people, occurred as little as eight days after Gough Whitlam had his commission removed by the then Gov General Sir John Kerr. https://www.parliament.vic.gov.au/publications/search-tabled-documents/details/3/4175

The Victorian Constitution Act 1975 came into effect on 1 December 1975, a mere three weeks after the Whitlam dismissal. With this sleight of hand 'gazetting' rather than a popular vote, this changed the balancing of political powers across the Parliament significantly in favour of the lower house. The 'Dismissal' event was the smoke and mirrors to avoid a referendum for the Victorian people.

Successive governments have done little to demonstrate the real effect of these changes of the Victorian Constitutional Act 1975. They have all sat mute, that is until Covid in March 2020. The new powers for the lower house had been held in abeyance while other building blocks were also put into effect to emasculate further the historical balancing of political powers within the Victorian Parliament.

The Steve Bracks Labor government built upon the Liberal treachery with the 2003 Reform Act that embedded the dominating political parties within the Legislative Council by the removal of the Legislative Council's power to withhold monetary supply bills, four-year fixed term parliament and eight state-electoral-voting-regions of five representatives per region. This significantly restricted small parties from having a say in government, while also and equally important, eliminated the censoring power of withholding supply during the annual appropriation Bill's passage through both houses of Parliament. These Constitutional building blocks implemented by both Liberal and Labor alike, with full support and endorsement by the Nationals and Greens, were the foundations laid for Dan Andrews to implement Covid mandates and travel restrictions. There is no benevolence within this pursuit of political power.

""Due to a machinery of government change, which takes effect on 1 January 2023, Local Government Victoria will move to the Department of Government Services (DGS).""

Local Government Becomes a Branch of State Government

Liberal Premier Geoff Kennett in the 90s went about turning local government (holding a federated relationship with the State government), from a locally-managed representative (again triune) body into a branch of the State government - administered locally. A bit of history is revealed below, showing that Liberal Jeff Kennet and Labor Dan Andrew's administrations have both built the fully-centralised 'local government' model as a branch of State-Government-administration across nearly 30 years of political manoeuvring and representative chicanery. The federated relationship at this level of government has been dismantled by them both, working for the same objective – totalitarian control.

""federation:: The act of constituting a political unity out of a number of separate states, colonies or provinces so that each member retains the management of its internal affairs"" *(continued next page)* It's important to recognise that up to this point these significant changes in the relationship between the individual and society occurred under both Liberal and Labor governments working together. The balancing of political powers across local government was also emasculated and centralised under Kennett's regional model, but even further emasculated and centralised under the Andrew's 2020 Labor government.

Councillor's hands and voices are now severely restricted through codes of conduct provisions. Local government was first morphed into regional corporations managed by a domineering CEO, and a mayor who is generally politically aligned with either of the two major political parties. The rot did not finish there.

The first Victorian general Act dealing with local government was the Local Government Act of 1874. The act empowered shires to be established in territories that could financially support them, and boroughs to be established in areas not exceeding 9 square miles (23 km2) with a population of at least 300. Promotion to town or city status was dependent upon the gross revenue of the council. Promotion was not automatic, but it was granted often.

Local government has been referred to in the Victorian constitution since 1979 (sec. IIA). It does not operate as to make Victoria a federation or protect the borders or powers of local government from amendment by executive order or act of parliament. Today, the constitution recognises it <u>"a distinct and essential tier of</u> <u>government"</u> and prohibits a council being dismissed by executive order, but grants significant powers to the state parliament in respect of local government. The clauses have been amended many times by parliament, but since 2006 the Constitution Act has required a referendum to further alter them....(ed-not necessarily adhered to I might add)

... In 1992, there were 65 cities in Victoria. In 1994, the Jeff Kennett government restructured local government in Victoria. His reforms dissolved 210 councils and sacked 1600 elected councillors, and created 78 new councils through amalgamations. In suburban Melbourne 53 municipalities were reduced to 26. The new local government areas (LGAs) were headed by commissioners appointed by the State Government. Democratically elected councils returned in 1996. end...

The Local Government Act 2020 received Royal Assent on 24 March 2020 – the start of Covid. Extract...

... The new Local Government Act 2020 is the most ambitious reform to the local government sector in over *ON TARGET*

30 years. The Act drives improved service delivery, innovation, collaboration, and sustainable futures for all Victorians through:

- better financial management and community engagement
- clearer standards of behaviour for elected representatives
- increased council and councillor accountability changes to election processes and candidate requirements
- increased transparency of council decisions.

The Act was proclaimed in four stages. The first stage was proclaimed on 6 April 2020 and final stage was proclaimed on 1 July 2021:

Stage 1 (complete) focused on electoral processes and the development of candidate training.Stage 2 (complete) focused on transparency and community engagement.

Stage 3A (complete) focused on integrity and governance.

Stage 3B (underway) focused on integrated strategic planning and reporting.

Stage 4 (complete) focused on procurement, complaints handling and key regulations articulating the powers of councils.

The implementation of the Act is nearly complete. The only remaining requirement for councils is to develop, adopt, and keep in place an Asset Plan by 30 June 2022. **End of Extracts...**

The state of Victoria has moved away from a federated political relationship between state and local government, to centralise power into the hands of the state lower house majority party -the Executive. Local government has also lost its balanced relationship across the council structure itself – councillors, aldermen and mayor, into a dominant state appointed CEO and HR/PR-active Mayor.
