## THE BACK STORY By Arnis Luks

Selectively picking over the results of the referendum, shows a clear contrast between 'inner-city' and 'regional or country' voting-patterns. There is also similar distinction between Northern Territory and ACT voting patterns; from those that readily live amongst aboriginal peoples, and those that don't.

As a constituted mechanism for settling matters, the referenda system was again the overall winner, with a clear Veto against constitutional change.

The laws, which were designed to protect Aboriginal cultural heritage in WA, were repealed by the state government on August 8, after a public backlash concerning potential costs, lack of consultation and confusion over how the new rules would operate.

The legal ramifications of a 'Voice' to Parliament will continue to cause reverberations as each State Parliament introduces and implements their own legislation, in spite of the referendum result. The SA government held back on any real-time demonstration of the state Voice legislation until after this referendum. How deceitful, but not surprising at all.

The real-time Western Australian legislative fiasco requiring a aboriginal-elder's permission to perform even minor earth works like putting in a fence post on your own freehold property greater than 1100 m<sup>2</sup>, contributed to this referendum result.

Leading into and out of the referendum, our online book sales increased by at least a factor of 5 to 1, with the two Geoff McDonald books, Red Over Black and The Evidence being the top sellers.

We will all have a better idea of the ramifications of what a 'Voice' really means across the next few election cycles with state legislation being implemented. ...a professor of politics at Australian National University, says the referendum must be seen in the context of what he describes as mainstream Australia's poor understanding of the country's brutal past. Australian history taught in schools has been largely focused on British conquest of land and white settler achievement, rather than the impacts of colonisation on Indigenous people, he says. Those impacts include the massacres, the cultural genocide, the policies of forced assimilation and integration which saw Aboriginal identity suppressed,

Indigenous children removed from their families; policies which have led to entrenched disadvantages that continue to this day, he says...

Despite the Universities and most Clerics having a field day with people's minds and cultural perceptions, there was sufficient political health in the population to Veto radical constitutional change. There was also a healthy scepticism of the validity of the 'voting and referendum' mechanism-itself managed by the AEC Australian Electoral Commission, with many attending for the first time as scrutineers. ...The TPPA, TTIP and TiSA agreements are a Commonwealth affair, controlled from the City (of London-ed). The author influencing much of the content in them was Tim Groser, a New Zealand National Party MP 2005-2015, and latterly Minister of Trade 19 November 2008 – 14 December 2015 and Minister of Conservation 19 November 2008 – 27 January 2010.

Groser is an old New Zealand bureaucrat and British puppet, having previously worked in the New Zealand Treasury, Ministry of Foreign Affairs and Trade and in the 1980s was New Zealand's Chief Agricultural Negotiator in the GATT Uruguay round. He has served as New Zealand's Ambassador to the World Trade Organization and has been the WTO Chairman of agricultural negotiations, and those of the Doha round as well.

Groser resigned from Parliament on 19 December 2015 to take up the role of New Zealand Ambassador to the United States of America in 2016, of course, primarily to further the City of London's work through the New Zealand Embassy toward encouraging the US Congress and Government to pass bills ratifying these agreements. In 2016, he will have two immediate neighbours in Observatory Circle in Washington D.C. where the New Zealand Embassy is located – the Clintons will be on one side and US Vice-President will be across the road.

Quite a coincidence for the start of the year 2016, when on the one hand the New Zealand Ambassador Tim Groser will soon be working closely with the US Vice-President to get these draconian trade deals urgently passed by the US Congress, and on the other hand, Sir Evelyn de Rothschild and Lady Lynn Forrester de Rothschild are presently funding Hillary Clinton's presidential bid. ### Elections and Referendas As Mechanisms To Release Political Pressure

A standing army is a factor for peace. An active militia is a factor against internal tyranny. An electorate, infused with the confidence that 'their will' must be sought out and prevail by their representative in the Parliament, is also a factor against political-party-tyranny.

ED Butler always reinforced the need to be clear about 'what it is that you want', and never get caught up in the bureaucratic haze of 'how to achieve' what it is that you want.

Remember the ACT, which is infused with Commonwealth bureaucrats, voted proportionally in opposite fashion to the rest of Australia with the recent referendum. Both titles are dealing with secret societies, in particular Freemasonry, more specifically Grand Orient Freemasonry. Paul A. Fisher walks you through the Papal Encyclicals about Freemasonry advocating an absolute zero-tolerance between legitimate Christianity and this secret-society. The Second Vatican Council has much to answer for, and for the record I am not, nor have ever been, a practising Roman Catholic. There are significant and irreconcilable differences between the traditional Christian teachings and the modern church (of virtually all denominations). I see this, not as a sign of progression, but rather, infiltration and heresy (or error). It is everywhere.

The folly of mankind is to think that his own thoughts can determine reality. This or that - ought to be so, and therefore it now 'is'. The plebiscite on homosexual union is a case in point. Traditional Christian teaching of the traditional family places this issue at the feet of God as the creator of all – the way things are and have been since the beginning. *In the beginning God created...*This truth cannot be redacted from the book of life. Man's role within creation is to observe 'that which already is and abide by it'. Look for the natural laws and obey them. A majority vote cannot determine a natural law.
