Ukraine Example

The policy was to destroy and displace the people from their homeland. This was achieved by managing both sides of the narrative, both the (US/UK controlled Ukraine, and Russian) administrations working collaboratively for a common policy-objective.

Ground War As A Legitimate Military Training Exercise

The real-life training of a ground war with Russia against Ukraine, has allowed the Russian military to perfect their craft in the modern setting of tank-traps, drones and satellite imagery. The US in the Middle East conflict against Saddam Hussein Iraq, had the significant advantage of night-vision-technology which was not available to the Iraqi forces. Similarly, Russian support for Syria allowed the elite Russian pilots to train in real-time. No doubt similar training and weaponry testing is occurring in the Ukraine and Middle East, in fact wherever a war front is occurring.

The Israel-Palestinian war is not a war at all. It is the destruction and displacement of the Palestinian people. The collective demonising of all Palestinians because of Hamas is simply a necessary tactic to legitimise the pogrom - the annihilation of the Palestinian people, who are semitic and resident in Palestine for millennia. It is their homeland in which 2 million are currently residing in their open air prison. Headlines such as this *'World Reacts To War As Israel Retaliates Against Hamas ... '* rationalises the annihilation.

The presence of two aircraft carrier groups in the Mediterranean, is to ensure the genocide of these predominantly Moslem people is not interfered with by neighbouring Moslem countries. Should they choose to retaliate, even with another false flag, the most advanced and sophisticated weaponry will be unleased upon them

The Nameless War was written by Capt AHM Ramsay, a former member of the House of Commons for the seat of Midlothian and Peeblesshire, UK. Interestingly, as a then current sitting member of the UK Parliament (May 1940), he was arrested and placed in Brixton prison for the duration of WWII until September 1944, without charge and without due judicial process. On the day after his release, he resumed his seat in the Parliament until the end of that Parliament the next year 1945. Statements to the press by António Guterres, Secretary-General of the United Nations, while acknowledging abhorrent attacks are attributed to supposedly both sides, he advocates a negotiated peace rather than military intervention to protect civilians.
