THE PSYCHOLOGY OF TOTALITARIANISM

Mattias Desmet has produced an analysis of 'The Psychology of Totalitarianism', - Mass Formation Psychosis - and ponders the rapid evolution of scientific thought-processes across these past 200 years that has led us to today's phenomena of scientific-dogma as a religion; revealed with the covid crisis and the propagation of statistics (that were hugely unreliable but must be obeyed).

Since 2005 up to 85% of scientific papers have demonstrated unreliability and false assumptions that were unable to be repeated/replicated by other researchers - the 'replication crisis'. The bias of the researcher is revealed in the false conclusions drawn.

As a remedial-masseur, when approached regarding an ailment, I consider only from my own expertise, similar to what I would expect from a chiropractor or surgeon or a GP issuing drugs - each approaching from their own discipline or bias.

The psychological development of a 3 1/2 year old child demands a 'surety' by asking the question 'why?' At some stage the befuddled parent answers, 'I don't know' and from this point on the child must accept that there are things unknown and limits to even the parents' knowledge. This is our mortal life and with the pursuit of surety - insurance for life - this leads to a false hope.

The Bible teaches us to pursue faith, hope and love. In analysing these 3 words in my mind's eye, I see a position of unknowing belief; that if I pursue this particular direction, I will likely achieve a goal somewhere in this realm, never exact, but an approximation amongst other approximations. Marriage is one example of pursuing the ideal - that may not be attainable except for only a few - 'until death do us part'.

Our life of exploring this world is not exact but somehow knowable. Dogma is a false reality, a strawman. Dr Iain McGilchrist points out in his masterly works, that we exist in the realm of poetry and metaphor.

After mentioning the sovereign citizen/strawman last week I realised with further consideration that their philosophical perspective is also based on their own 'strawman' - a 'subjective fiction' drawn from limited understandings to become a dogma much like Marxism and Libertarianism. This is in a similar vein to our mainstream historians fabricating and/or massaging facts to suit their own political policy-objective of cultural collapse of the host nation. Real 'science' adjusts theory/philosophy to observed reality. 'Dogma' adjusts observed reality (facts) to suit theory/philosophy.

This will brutalise entire families again, just as it did 1975 / 2006 - adjusting the observable facts (law) to suit the philosophy. This is a deliberate pursuit of societal breakdown as it was under the Humanist Lionel Murphy's original Family Law Act 1975.

Man as steward and not master of nature, must observe and adhere to 'its natural' rhythms and flows. This 'resonance' with 'the way things are' is revealed 'from within the mother's womb' before the child is born, on to the 'just right' that Douglas referred when building a project. The natural law, the canon, is of a thing to be pursued without an exact end, or a complete understanding. 'Only do unto him what you would have him do unto you' - cannot be written down as an exact law with the medium of imperfect words but held as a principle to be pursued within all law and societal customs.

Since before the Industrial Revolution man has increasingly become disconnected from these rhythms and forms of the natural world, separated from his craft and those receiving his finished work. Wayward children and

adults alike are often sent to an 'orientation camp' in the country to achieve exactly that – re-orientation.

The joy of doing the job/craft well has been lost. David Graeber analysed this perspective with his written work 'Bullshit Jobs'. The separation from nature leads to feelings of increased anxiety and helplessness in the pursuit of earning a living - the psychological breeding ground for increased anxiety 'looking for surety' – leading towards dogma (surety) and totalitarianism. The UN driven (sustainable development) 'light building code' separates families from the soil by placing them further and further away from engagement with the earth and those natural rhythms, into high rise chicken coops for humans.

I found that Desmet's work aligns closely with both René Girard and Iain McGilchrist writings. I did not uncover any glaring inconsistency, except perhaps in the area of 'conspiracy'. Desmet analyses the conspiracy perspective providing several valid examples, and then discounts the conspiring point of view entirely!

I immediately thought of Barabbas and The Christ with the 'manipulating of the crowd', Brutus and the Senate in Shakespeare's play 'Julius Caesar', and felt his closing down of this conspiring perspective was premature when his research had uncovered so much else of valid importance.

Chicken and the egg if you like. Which came first, the psychological circumstances driven by 'design or purpose' (policy) leading towards totalitarianism, or 'random' circumstances that produced the psychological seedbed for totalitarianism. A reading of 'The Protocols', the 'Communist Manifesto', or the history of the money-power should dis-'spell' this Darwinian perspective of random chance leading to totalitarianism. Government/Cabinet Publications such as 'MindSpace' reinforce the planned/conspired ends or objectives of mind manipulation:

A RETURN TO WINNER-TAKES-ALL CUSTODY BATTLES By Bettina Arndt

This week a television crew from the Japanese public broadcaster came to Sydney to interview family law specialist Justin Dowd, a former President of the NSW Law Society. Japan is considering a move away from mum-custody towards 'joint parental authority' – which recognises that it's in the best interests of children to have both mum and dad remain involved in their care.

The Japanese crew came to Australia because they acknowledge this country as one of the world leaders in encouraging separated parents to share decisions about raising their kids. That achievement stems from John Howard's path-breaking 2006 reforms promoting 'equal shared parental responsibility' which resulted in a major increase in care from dads, more shared care, better relations between parents, and less litigation.

The result was improved children's well-being, according to UNSW research, and the reforms were a big hit with the public, 'overwhelmingly supported by parents, legal professionals, and family relationship service professionals', according to research by the Australian Institute of Family Studies.

Yet Justin Dowd had to tell the Japanese crew that it's all now at risk. The Labor government has announced draft legislation that will take Australia back to the dark ages of the winner-takes-all custody model.

The fall of dynasties, the Bolshevik Revolution, WWI and WWII saw the destruction of old alliances and boundaries, the convulsions in religion, morals, family life, economic and political conduct, decadence in music and art can all be traced back to mass indoctrination (mass brainwashing) practiced by the Tavistock Institute Social Science scientists. Prominent among Tavistock's faculty were Edward Bernays, the double nephew of Sigmund Freud. Political Will-Power

Each week I report of developments towards the world slave state. This pursuit is unrelenting, and at times appears daunting to the point of mental exhaustion. England, on the shores of Botany Bay January 26th 1788, provided the highest in civilisational achievements (culture) then known to any nation. The Canon within the common law, Trial by Jury, Habeas Corpus, Representative Government, Parliamentary Democracy. And we Australians, our forebears, have incorporated the best of these legacies with Trinitarian Constitutionalism (from the Athanasian Creed in particular) – 'Humbly relying on the blessings of Almighty God' within the Preamble. The principle

of ‘divisions of power’ and ‘unity amidst diversity’, when upheld, provide the highest form of civilisational framework man has found to date, in a moral and responsible environment. This high-water mark of civilisational achievement, our Constitution, is under significant attack by a counter-philosophy – dialectical materialism – the clashing of opposites, man as only ‘matter in motion’.

CH Douglas, in *Realistic Constitutionalism* wrote that the British Constitution was not written, but rather, grew as an organic body of knowledge limiting/balancing governmental power. Britain’s institutions have been under much psychological attack and 5th column activity, (as has ours), to have their organic/trinitarian constitution subverted – the Lords and Monarch are both emasculated and hold only limited power in comparison to the Commons. These 5th column weeds around both, ours and their constitutions need ‘addressing’.

A few glaring weeds at home might be ‘the loans council’, to once again allow each state to source their own funds from their own state bank – debt free when necessary. In other words, ‘states rights’. The Franklin Dam high court decision must be revisited, to once again limit the realm of the federal government to make binding treaties with foreign entities that, since the Franklin Dam decision directly affected every area of states’ rights to determine their own affairs – thus again restoring federalism. The Victorian ‘Constitution Act 1975’ another glaring moment for opportunity. Regional Councils? The list goes on.

This task will take many generations to achieve a suitable end position, which will never be perfect, but directionally correct in this imperfect world. Magna Carta was not so much a regression, but an upholding of ancient rights and freedoms. These past 60 years has seen a massive ‘curtailing of our freedoms’ under the guise of security (surety of life). The pursuit of centralist policy is planned as a deliberate objective towards world power, for the few to control the many.
