#### Koalas

In another article of how science can be incomplete, in the 1920s 18 koalas were introduced onto Kangaroo Island, situated about 100 km south of Adelaide. In 2019-20, 100 years later, there were an estimated 48,000 koalas on the island (during that extensive bush-fires previously reported in the *OnTarget*.) 8,500 koalas were thought to have survived after the fires, however a later survey showed that 15,000 was closer to the mark, of which 20% were within the 'blue gum plantations', which had also been introduced and planted out on farmland around the year 2000. The telling point is that they were not native, neither were the blue gum plantations, and both are now in plague proportions, again, competing for available food sources. At the outset of the release of Rabbit Calicivirus Disease (RCD), rabbit numbers were estimated at <u>two to three hundred million across Australia</u>. The rabbits compete with livestock for available pasture, kill young trees and shrubs, contribute to soil erosion and disturb the soil during burrow construction, this being a major threat to native mammals... Rabbit Calicivirus Disease (RCD) was first reported in China in 1984, and has since spread through over 40 countries, killing millions of rabbits. The virus was imported into Australia to be used as a biological control agent for wild rabbits. It's premature escape from Wardang Island South Australia in October 1995, was followed by the official release throughout Australia in October 1996. Scientists predicted that 60% of the total rabbit population would be eliminated. Later tests showed the virus would kill 99% of all adult rabbits infected.

Rabbit Calicivirus Disease (RCD) can be found in every State and Territory within Australia....Current data (circa 2000-ed) shows that rabbit numbers are down in many regions, but it varies. Farmers and rangers working in the dryer areas have reported an extraordinary comeback of native vegetation since the release of RCD, and have seen an increase in native wildlife populations. In one area kangaroo numbers have risen sixfold...

The Cain Toad is yet another story.

#### The Conquest of Nature

David Blackbourn's book title intrigued me – '*The Conquest of Nature -Water, Landscape, and the Making of Modern Germany*'. Blackbourn's writing about harnessing the giant Rhine River system, realising the industrialisation of Germany as being the powerhouse of Europe. That once meandering river, with bogs, swamps and tributaries has now become a fast-moving torrent of water navigable for trade. The Austrian Schools of Economic Thought incorporates a similar perspective of conquest, even using the bold descriptor '*Red In Tooth And Claw*'. There is no resonance, nor harmony, nor husbandry from this philosophical point of view with the natural world - of conquering nature.

I regularly push back against this philosophical perspective because it is in the ascendancy and has grave repercussions on our lives and the planet. Many advocates of this philosophical trend are good people but misguided. This error in thinking must be responded to.

**Matthew 17:23-26** And when they were come to Capharnaum, they that received the didrachmas (tax collectors), came to Peter and said to him: Doth not your master pay the didrachmas? He said: Yes. And when he was come into the house, Jesus prevented him, saying: What is thy opinion, Simon? The kings of the earth, of whom do they receive tribute or custom? of their own children, or of strangers? And he said: Of strangers. Jesus said to him: Then the children are free. But that we may not scandalize them, go to the sea, and cast in a hook: and that fish which shall first come up, take: and when thou hast opened its mouth, thou shalt find a stater : take that, and give it to them for me and thee.

Fishermen realising a sufficient catch for the day, don't look for a coin in the mouth of each fish. The psychological presumption is there though, of a correspondingly-proportional amount of money in man's system of finance, with every successful harvest or advancement in production technology - the same hope with every producer, that the money will be realised in the marketplace by *March* 2024

the payment for goods. However, working harder and producing more will not resolve the financial-debt question. The financial system is rigged to never be able to redeem debt, and operates separately from the economic system.

## The levels of debt are so astronomical that everything that has ever been produced from the beginning of mankind onto our modern industrial age, had it been placed into the marketplace today and been sold today, the funds received, if they were there which they are not, would still be insufficient to redeem all levels of debt.

Does this make sense yet? I know this statement is inflammatory and not able to be substantiated, however, it does illustrate my point. No matter how much we produce, no matter how hard we work, we will never redeem debt.

Australia is open for business all right; as a massive quarry for export. The giant excavating machines gorging the iron ore, bauxite and coal, copper, gold and uranium ore from the earth at unprecedented rates is still insufficient. **Irredeemable Debt Must Be Considered As A Major Problem** 

If there is no realistic resolution to financial debt-redemption, the financial enslavement of the world will come while the abuse (read 'conquest') of the planet to reconcile these irredeemable debts will continue.

# *Every nation, every industry, every individual family, directly or indirectly, is financially enslaved to these international moneylenders.*

Australian history of the 1930s depression years, the NSW Labor Premier Jack Lang refused to pay back state debts to overseas banksters. All the political powers of that day, MSM, industrialists, politicians including the Gov Sir Philip Game turned against that patriotic leader. His sacking is our hi-story that needs to be reconsidered in the light of this irredeemable debt.

The philosophy of utility, or utilitarianism, or mechanistic utilitarianism, however you want to describe it is wrong, and yet many advocate this thinking. The synchronism of political-antagonists becomes obvious from this perspective. Both collaborate against the natural order of husbandry, nurturing and care.

While I regularly travel around Australia, I see the wind turbines and solar panels as an environmental scourge on our beautiful planet, yet the religion of 'environmentalism and sustainability' advocates these monstrosities as a necessary evil to save the planet. This is a divergence from common sense. I rather quickly uncovered my own divergence

My wife and I practice husbandry on our block of land, by planting out nitrogen-fixing trees in between the fruit trees, by occasionally practising companion-planting around the veggies, ensuring our bees have an adequate supply of water and flowering flora, and making the effort each day to feed our chooks a good amount of greens which result in a vivid yellow yolk in their eggs.

While that previously written sentence appears to say nothing controversial, the fact is that I cannot substantiate scientifically that the trees I have called

nitrogen-fixing do perform that task. I have taken it on face value from the Permaculture website, having watched the videos and bought and read their books, that this does occur, nitrogen is fixed by these trees, firstly into their root-nodules, and that lightly pruning (chop and drop) causes these nodules to release supplementary nitrogen to other flora in the area.

I came across a Youtube video that challenged this theorem (a general proposition not self-evident but proved by a chain of reasoning) by a young Canadian gardening practitioner-and-theoretician who has spent a year looking for scientific evidence to substantiate this theorem. Now while a year is not a long time, it's hardly a blink in the history of husbandry and Permaculture management. However, this person is convinced, that because they couldn't find any scientific literature in a year of searching, this 'chop and drop' and nitrogen fixing nodules perspective amounts to scientifically-unproven. What this challenge does is reinforce how readily I was prepared to mimic what others (holding some authority of practical application) were saying.

Can I substantiate with my regular pruning - 'chop and drop' of these nitrogen fixing trees, that they enhance the vitality of my fruit trees by providing supplementary amounts of nitrogen? It's a valid question. The thoughts on my self-evident mimicry lead me directly back to René Girard, and how quickly I was prepared to repeat what I had been instructed. I need to always substantiate my thinking by seeing the results incarnated in the real world. It's that simple – try it on the dog as Douglas said.

Well, we periodically do prune the nitrogen fixing trees, and the other flora in the immediate area does not appear to suffer, but rather, they all appear to thrive. The explanation of nitrogen fixation may not be the exact scientific answer, but the husbandry practice appears to work. 'How' is a question deserving further and ongoing investigation, that can be trialled without producing a more conclusive answer than 'it's a theorem' I am working under. To the best of my knowledge, it appears to work. This question and answering can go on forever - rhetoric. At some point you choose to hang your hat onto a theorem that you can accept. An explanation as to 'why things are so?' **Jennifer Marohassy writes:**

If the collective level of debt, of private, corporate and government is so astronomical as to be irredeemable, then even those that hold some equity in their existing homes will find it increasingly difficult to continue treading-financialwater. The next generation experiencing financial hardship will find it *nigh on* impossible. Opting out of the system, as the Sovereign Australia movement advocates, also provides no enduring solution against the philosophical riddle of this age.

The Calvinistic/Puritan perspective that 'if a man does not work that he shall not eat' needs to be reconsidered in the light of the modern-industrialised-age of robotics, automation and abundant supplies of energy. If the work is not there for the next generation, which previous governments have ensured it is not with various trade agreements and such like, then this next generation has no chance within our existing financial apportionment. The system must be readdressed as we fall deeper and ever deeper into this debt quagmire.

If we fail at this time to address this specific issue, regardless of who, and how honourable our intentions are within government, <u>we will own nothing</u>.

The longest road back begins with the first step. As a nation, we must turn back to regain control of our representatives - away from the political parties. Political power must reside within communities, from which is the legitimate, cultural and philosophical right as recorded in our Limiting Constitution.
