Catch Me If You Can

The stakes at play are so great that there is no moral anchor in the pursuit of any opportunity for exploitation. The cats have been let out of the bag. Like Donald Trump, Santos has had to fight their way through the courts to continue with their project. Truth is almost no defence. By the look of it, truth had little to do with the case at all.

The real question in this legal charade is, if these Aboriginal Corporations were able to stop the project from going ahead, how would these same Aboriginal Corporations derive their benefit? - What happens after the court case victory.

I see a potential model here, an MO *modus operandi*, with the 'World Heritage Listings', initiated under Liberal PM Malcolm Fraser's administration of which John Howard was a very active member, of vast tracts of mountainous regions, waterways, old-growth forests and the like. In Victoria the government is increasing taxation for anyone who has an investment-property or second-home. In this expansion of the public/private partnership, Libertarians are calling for smaller government, *ergo*, more private in the public/private partnerships. Gobbling up the little fish in favour of the big fish is standard fare for both Neoliberalism, and/or Libertarianism.

There is also this question of who our bureaucrats are, which not only includes public servants in particular leaders of departments, but other civil services as well. These two observations bring me to the conclusion that traditional Australia finds no representation within the two major parties. Genuine free enterprise, which is Conservative, is markedly different from monopoly, whether it be transnational corporations or centralised bureaucracies. Both are differing forms of monopoly, but monopoly, nonetheless. Political parties considered in this light are anathema to representative government. Representative government will not find a voice through these political groupings. The people are left high and dry without genuine representation in our parliaments.

Vested interests control political parties. The major donors, whether it be the entrepreneurial developer who wants greater immigration numbers to boost personal profits without considering the national interest, but only their personal profits. Or worse still, the secret donations that bypass the Auditor to place their own man or woman in a major position of interest. This selfishness is permeated through both Neoliberalism and Libertarianism. Monopoly Capitalism, which is simply Communism in disguise, is simply another name for this same disease, whether either Liberal or Labor.

We are social beings. When the Irish were left to starve by the absentee puritan landlords, rather than be fed with the other crops that had not failed, this same trait was demonstrating a similar fashion in Shakespeare's play 'The Merchant of Venice'. The merchant considered profit as god, something to be sought after at all cost regardless of the potential suffering to the victim. A moral ethic was lacking in this perspective. This is where we are going as a civilisation. Those who would oversee

the world, hold no moral, nor ethical anchor. Prostitution and Slavery are simply legitimate forms of employment.

Taxing the Home is the Real Issue

The moneyed-class of 18th century England were able to expunge the landed-class by taxation of their property. Without sufficient income the property falls to market forces. This is critically important to recognise that the home as the sanctuary of every family must be free from all forms of excessive taxation. As we are moving further away from our own manufacturing and industry (regardless of causes such as advanced technology or jobs going overseas), Australians will become more and more vulnerable to this form of exploitation by taxation. Without a regular income the financial wolves will pick up Australian homes for a song. The average Australian homeowner will be the loser. We will become a nation of renters instead of homeowners.

Where is traditional Liberal or Labour now?

Australia Day January 26th – A Timely Reminder Of Who Foundered And Developed This Commonwealth

Over a period of 236 years the Commonwealth of Australia would have been founded, explored, developed, constituted into a Nation-State, successfully processed two major wars of defense, and now finds itself being confiscated by transnational corporate bodies ably financed by central banks. The Dutch East India Company, the British East India Company, have both been superseded by the WEF World Economic Forum and the WHO World Health Organisation, existing under the banner of the UN United Nations and TPP Agreements. Our financial sovereignty was signed over in 1924 by the conservative Bruce-Page government to international gangsters called central banks. We have been indebted to these central bankers ever since, simply by them issuing book-entry-credits from which our nation can continue to produce. For nearly 12 years prior to this indebting-treachery, we expanded our civics programmes to open major transport networks and prosecute the First World War, all debt free. We demonstrated what we were capable of doing.

As separate nations, we are not united, as each nation competes for a reducing market share. In fact, the UN security-veto places the real seat of power within the UK, USA, China, Russia, and to a lesser degree France as controlling interests through the UN. The square mile of London and Wall Street are somewhat closer to the actual citadels of worldly power. The immediate military response in the Middle East by USA/Zionism/UK to any threats to trade, access to vast mineral-reserves, and increasing market share, shows them readily working in concert, operating above all other national governments.

The only counter to this type of financial black magic that has been usurped in order to gain control over the whole world, is the proposals of that genius electrical engineer Clifford Hugh Douglas, who recommended that new financial credits were too important to be placed

into the hands of monopolistic individuals, nor even the national governments. New credits were to be issued in a de-centralised manner, by handing over to every person, equally within each nation, a National Dividend to balance purchasing-power with productive prices. These new credits allowed the economy to balance their productive capacity with the available spending power so as each imputation of costs was reconciled at the marketplace. Debt was reconciled in a permanent manner. The Year of the Jubilee was allayed. Civilization had finally overcome financial tyranny through God's bounty and benevolence. **'On earth as in heaven'**.

Exports, as a means of drawing in an expanding market share to reconcile costs, would become almost obsolete, except for items that could legitimately and readily be traded or exchanged. Economic competition causing war between nations, would be permanently arrested.

Not through monopoly-controlled training-institutions whose tailored narrative seeks to obscure their own exploitation, but rather through an open-source medium that looks at the natural world and recognises production as a community function. That the purpose of this function of production is to provide the needs of the community which must be met in the marketplace with sufficient purchasing power to reconcile the costs incurred in the processes of production.

The Roman Catholic encyclical *Rerum Novarum* deals with the differences between labour and wealth (the moneyed class) that Major Clifford Hugh Douglas has reconciled. Without incurring further debt, the community can purchase what it produces. The financial-wolves'-teeth are permanently extracted.

...5. It is surely undeniable that, when a man engages in remunerative labor, the impelling reason and motive of his work is to obtain property, and thereafter to hold it as his very own. If one man hires out to another his strength or skill, he does so for the purpose of receiving in return what is necessary for the satisfaction of his needs; he therefore expressly intends to acquire a right full and real, not only to the remuneration, but also to the disposal of such remuneration, just as he pleases.

Thus, if he lives sparingly, saves money, and, for greater security, invests his savings in land, the land, in such case, is only his wages under another form; and, consequently, a working man's little estate thus purchased should be as completely at his full

disposal as are the wages he receives for his labor. But it is precisely in such power of disposal that ownership obtains, whether the property consist of land or chattels. Socialists, therefore, by endeavouring to transfer the possessions of individuals to the community at large, strike at the interests of every wage-earner, since they would deprive him of the liberty of disposing of his wages, and thereby of all hope and possibility of increasing his resources and of bettering his condition in life. ***
