FROM THE SPECIAL SCOREBOARD EDITION OF *American Opinion*, JULY/AUGUST, 1965, TO WHICH REFERENCE WAS MADE IN OUR LAST ISSUE, WE CONTINUE THE SECTION DEALING WITH THE U.S.A. AND THE MEASURE OF CONTROL OVER ITS POLITICAL AND ECONOMIC LIFE EXERCISED, *secretly or openly*, BY THE CONSPIRACY THROUGH *all* ITS INSTRUMENTALITIES:

Despite the best efforts of Communists in the news services to cover up and confuse, most people have learned a little something of what happened when a horde of termites from all over the country, led by half-crazed ministers and professors, swarmed over the small town of Selma, Alabama, in typical demonstration of Communist activism (see *May*, 1965, pp. 1-10). But it was not the foul and obscene behaviour of the invaders that was shocking, for that was only to be expected. What was really significant was that the whole affair was planned in the highest echelons in Washington before October 3, 1963, when Brigadier General Echenberg with aides visited Selma to survey the terrain in preparation for occupation of that town by the U.S. Army as soon as the invading swarm had created enough violence to provide a plausible pretext. Only the remarkable patience and restraint of the abused and insulted people of Alabama averted the day of which Communists dream—when the American Army can be used on the streets of their own towns and cities.

Open race war is practically upon us. Intelligent Negroes, such as Manning Johnson and Julia Brown, have striven to avert it, but to little or no avail. Our white termites are gradually having their way. Blood-lust is in the air; it is a contagion borne on every wind. Two years ago, we may be sure, most readers of *Life* were a little startled when that publication made its contribution to the kind of race relations it wants by publishing an interview with a Negro cab driver who exhibited to the reporter "a black revolver" and explained how difficult it was for him to restrain himself from using it on the whites who rode in his cab and so provided him with a living. By now, such statements have become commonplace. In New York, for example, something that calls itself Allah 13 X proclaimed to its enthusiastic disciples, "We're goin' to kill the cops and all the white people—women and children, too. We're goin' to start a blood bath now." That was merely typical of the increasing frankness of the "Civil Rights" movement. That, of course, is what the real promoters of "integration" intended from the first. The delightful little rhyme,

*Have a Civil Right:
Kill a White.*

is heard with increasing frequency—now even in the South, where mutual understanding and friendship between the two races prevailed until the termites moved in. It is probable that prompt and firm action, based on a frank recognition of the obvious fact that the whole racial agitation was designed and is directed by the International Communist Conspiracy, could yet

avert from the United States the horrors of the Congo. But of such action, there is little prospect.

Despite some bungling, the Communists were able to exploit their assassination of Kennedy. To be sure, Oswald was caught; the hastily improvised way in which he was silenced couldn't be made to look plausible; and the *Worker* was certainly indiscreet when it nominated Earl Warren for the cover-up job before he was appointed to head an illegal and un-Constitutional Cheka.* But despite these little fumbblings, the enemies of mankind were able to whip up such hysteria among the brainwashed and the unthinking that Congress was somehow bullied into doing what, in the opinion of all observers in Washington, it would never have done, had Kennedy remained alive. It enacted the "Civil Rights Act," which, as the Honorable Ezra Taft Benson warned, "is part of the pattern for the Communist takeover of America" (see 1964). The actual takeover, therefore, has now begun.

Title VII of that act of betrayal becomes effective on July second, and goon squads are being trained in Washington to enforce submission. Under this act of flagrant Bolshevism, every person who employs one hundred or more persons this year (fifty next year, twenty-five in 1967) must have *all races and religions* proportionately represented at *all levels* of his staff. Squads of arrogant agents, paid by the taxpayers and called inspectors, are commissioned to harass all employers. Employers who are not sufficiently servile and submissive to their masters will be hauled before a Soviet-style *secret* "tribunal." If the victim discloses to anyone what was done to him at his *secret* "trial," he is automatically subject to fine and imprisonment. And even if the businessman keeps his mouth shut, the commissars can imprison him without trial by jury. Obviously, the differences between the United States and the Soviet Union are rapidly being effaced.

Although for all practical purposes the states are soon to be abolished (the names may be retained for administrative districts), the Communists have not neglected them. In a very considerable number of states they have induced the legislatures to enact "mental health" laws to facilitate the incarceration of troublesome Americans. The provisions of the various state laws differ somewhat, but they all deprive an American of the right to trial by a jury of his peers (sometimes substituting a "panel")

FROM WEEK TO WEEK

We have referred on previous occasions to the informed estimate by careful observers that the odds in favour of the International Finance-Communist Conspiracy being successful are about four to one. At first sight this seems to be a pessimistic estimate, but in fact it is not. An estimate by the same observers some years ago put the odds at about a hundred to one. In either case the odds show that we have a chance of defeating the Conspiracy, but now our chance has greatly improved.

The progress of the Conspiracy is rather like the rising level as water is poured into a bottle, at first by slow drips so that the level does not appear to rise in any comparatively short period of time, but latterly by a steady stream which has made the rise perceptible. It is the perception of this rise, and the systematic drawing of attention to it which has improved our chances. It was the intention of the Conspiracy so slowly to shackle us that we would remain unaware until too late, when the shackles would be drawn tight.

But awareness too is rising like water in a bottle, and at an increasing rate. The sale of the literature of exposure has risen far more rapidly than we anticipated, and orders come in from unexpected quarters. Most of the books sold are likely to be read by several people, and discussed even more widely. The success of *imperceptible* shackling was virtually certain; but now we can back a *chance* against a certainty. The Conspirators are now in a hurry, and so draw attention to themselves by their increasing blatancy. But against them the tide of public opinion is rising, as shown, for example, by spontaneous demonstrations against Communist demonstrations, and an improving quality in letters to the Press, and the increasing sale of conservative periodicals. At some point, perhaps when by persistent exposure we have reduced the odds to three or two to one, there will be a sudden revulsion against the traitors who promoted two world wars and the great depression; who financed and continue to finance the Revolution in Russia and elsewhere; subverted national constitutions; and continue to promote crime, vice, corruption, immorality and violence, all in order to destroy Christian civilisation as a prelude to a world police-state, de-populated to a "safe" level, and ruled by those presently *in control* of Inter-

national Finance, International Communism and International Socialism—the Tripod of Tyranny.

Yet they *can* be defeated. They have not so far been finally successful, and sufficient exposure will destroy them. That is the task in which all men of good will should ultimately join, as tens of thousands perhaps by now millions, already have.

Morality, religion in the active sense, and integrity are active *forces* in the community, as our enemies well know. In settled times they quietly sustained society. In our deliberately disordered times, however, they need to be focused on the inner cause of our mounting troubles, as the sun's rays may be focused to a point which will ignite paper. And who can doubt, if we *work* steadily towards a show-down with our enemies, what the outcome will be? There are signs, for those with eyes to see and ears to hear, that a showdown is coming. By now, probably millions of people have a latent knowledge, or at least awareness, of the Conspiracy, and some event, at some unpredictable time, will bring about an explosion of wrath which will destroy the enemy and bring us to salvation. Let us work to that end.

The weekly news-paper, *Human Events* (Washington) in its issue for July 17, 1965, quotes what we believe to be the very reliable *Allen-Scott Report* on what took place at the Hanoi "labour conference" held from June 2-6 inclusive, and attended by delegates from all over the world. According to the Report, the conference cost the Hanoi-Peking axis over half a billion dollars.

"Nothing was left to the imagination of the 600 delegates. *Country by country* they were briefed on how to implement the 'vigorous mass aid Viet Nam and resist America movement' which the hosts said 'is unfolding throughout the world'. This labour conference obviously was vital to Mao's strategy." [Our emphasis.]

The conference was, in fact, a briefing in integrated sabotage as appropriate to the various countries represented, in the main aimed at disrupting transport and promoting anti-war demonstrations. And so we have seen the Teach-ins and other propaganda activities, combined with water-front strikes and other attacks on communications.

In the meantime, the U.S. refrains from bombing vital targets, but terrifies the public with postponed announcements of vastly increased military efforts—probably made in the secure knowledge that the Communists will have won before the efforts can be effective. The 'management' of the news concerning Vietnam ought to be enough to convince anyone of the complicity of the invisible government of the U.S.A. in the strategy of International Communism. And when our turn comes, it will be "too late" for the U.S. to do anything.

It is vital to do everything possible to inform public opinion to a point where it will *force* the U.S. government to *win* the *war* against Communism. Conferences with a winning enemy are

consisting of, or easily dominated by, "experts"). Control of the victim's property usually passes to "the state," so that he and his relatives (if not independently able to raise the money) will have no means of employing assistance.

The "mental health" hoax is too elaborate to be outlined here; for an excellent survey, the reader is referred to *Bats in the Belfry*, by Ellen McClay, with a foreword by Dr. Granville F. Knight (Rosewood Publishing Co., Los Angeles; 253 pages, \$1.75). It will suffice to note here that the number of "mentally ill" available for kidnapping is simply enormous. The experts' definitions vary, of course. Pearl Buck, an amateur enthusiast, suggests that "All white people are mentally ill."

Dr. Albert Ellis, who directed the New Jersey State Hospital in Graystone Park until he climbed to higher things in the State Department, in his book, *The American Sexual Tragedy*, opines that all men who are *not* homosexuals are "fetishistic," since they have the delusion that women are capable of receiving love, and must therefore be treated as "victims of psychiatric illness." The controlling definition, however, will probably be the one provided by Alger Hiss's pal and protege, Dr. Brock Chisholm, who speaks with authority, since he is the head of the teeming World Health Organisation that Hiss sponsored and you financed. In an article published in the official journal, *Psychiatry*, Dr. Chisholm pointed out that "mental health" depends on "eradication of the concept of right and wrong." You may estimate for yourself the number of Americans who are so ill that they do not understand that all morality is "perversion," and accordingly suffer from the "insane idea" that there is a difference between good and evil. (It may not be a coincidence that Chisholm's enormous brain throbs with another worry: how to prevent white people from having children,* since, of course, we'll have to get rid of the white race to have One World.)

The attention of the American people was first drawn to the real problem of "mental health" on October 1, 1962, when, in obedience to the specific demands of the Communist Party, a gang under the direction of Nicholas Katzenbach (now Attorney General of the United States) kidnapped General Edwin A. Walker in Oxford, Mississippi, and hustled him to the "Mental Health" prison in Springueld, Missouri. General Walker's friends prevented his destruction, but less prominent victims have had no one to help them.

The Department of "Health, Education, and Welfare" has a special license from Congress to import even Reds as "mental health experts," and for years it has been bringing in eager experimenters from all over the world, and, of course, passing them on to state institutions. It is often very difficult to find out who reigns behind the fortress-like doors of "mental health"

*Brock Chisholm's palpitating cerebrum may have derived some comfort from the report made by Dr. Joseph W. Goldzieher of Trinity University to the Southwest Foundation for Research and Education. Dr. Goldzieher reported that, by extending a little the principle on which fluorides are now put in public drinking water, it will be possible to administer to the entire population of the United States drugs which will make them sterile. He was quoted in the Press as saying that "there would be no ethical objection to the sterilisation of entire populations," since those who wished to have children could use antidotes to the poisons administered by governmental mass-medication. Of course, those who follow the Chisholm Trail to an Earthly Paradise will have the problem of keeping the antidote out of the hands of white people when this logical extension of fluoridisation of water is put into effect.

institutions, but enquirers were finally able to learn that the "psychiatric and medical" staff of a state hospital in the Midwest consisted of at least eighteen members, not one of whom was of American descent. It was impossible to learn how many, if any, had acquired American citizenship, or in what way. Judging by appearances, names, and broken English, most of the "experts" were imports from the Middle East, Poland, and China; some seemed to be from the Philippines or Latin America. Their qualifications were not stated, but it was learned that some of these specimens had tried *nine* times and as often failed to pass the minimum examination for a license to practise in that state, but were nevertheless retained on this exemplary staff.

Thus far, "mental health" has been used on only a very limited scale to imprison persons who get in the way of the Communists; the time for wider use is not yet ripe—but it is ripening rapidly.

Incidentally, we should note that while the principal object of "Medicare" is to destroy the independence and integrity of American physicians, it will inevitably create a "pressing shortage" of physicians and nurses. Communist provinces are sure to have a surplus of medical workers they will be glad to export to the United States to relieve the "shortage".

Our schools, psychologists, cinema-producers, and publishers have been very successful in inducing an obsession with sex that makes people oblivious to all the other values of life. With the benign approval and protection of the Warren Court, the nation has been flooded with pornography of the most disgusting kind, and just to make sure that no child escapes the blight, many "educators" are systematically "throwing" it at the children. Years ago, Dr. Pitirim A. Sorokin of Harvard in *The American Sexual Revolution* pointed out, as a simple and indisputable fact of sociology and history, that no nation or civilisation can long survive an attack of sexual mania, and he plainly stated at that time that unless the American people effected a rapid and drastic reformation, the United States was doomed to disintegrate and disappear. It is easy to guess what he would say now, when the sex-cult has gone far beyond even his gloomiest prognosis.

Far more alarming than promiscuity is the almost incredibly rapid multiplication of degenerates that are neither male or female. Those strange creatures, whether the consequence of biological deterioration or of moral corruption, form an alien species and, as many Americans first noticed when Lyndon Johnson's closest assistant, Walter Jenkins, yielded to the degenerate's strange urge to practise perversion in public,* the species has attained enormous power in Washington and throughout the country. The perverts have now organised their own societies and leagues, publish their own disgusting periodicals, and are now beginning to agitate for their "minority rights." In some areas, under the auspices of that old harbinger of subversion, the American Civil Liberties Union, they are now giving public lectures on the joys of degeneracy to "promote

*This is a point which should not be overlooked in forming an estimate of the creatures. Like Jenkins, many of the perverts in the highest levels of our government have been arrested several times for such offences. They draw some of the largest salaries paid in this country, and no one can argue that they cannot afford a dollar for a cab-ride home or three dollars for a room in a cheap hotel, where, under the laws of the District of Columbia, they would be immune to arrest. Instead, some strange compulsion drives these creatures to practise their perversions in public parks and in public buildings, such as the Y.M.C.A., where they are subject to arrest when caught in the act.

understanding."† The local head of the largest federation of "male" perverts in Washington testified under oath on August 9, 1963, that, to the best of his knowledge, there were about a quarter of a million homosexuals in Washington and that from 200,000 to 250,000 were on the federal government's payroll. A recent book by J. Z. Eglinton, with a postscript by the great "mental health" expert, Dr. Albert Ellis, under the disingenuous title, *Greek Love*, suggests that men have a "right" to seduce boys, proves that boys from "about twelve to sixteen" are the most fun, and provides warm and glowing "case histories" of the fun thus had by professors, scout masters, graduate students at Harvard, and others so intellectually superior that they are above vulgar "prejudices."

Considered merely as a leprosy of society, this degeneracy would be sufficiently alarming. The single example of the State Department will suffice to show the intimate connection between perversion and treason.

Communist domination of many departments of the federal government is too obvious to require much comment. The State Department, after burning all its security records in the field (of which there were no duplicates anywhere), is openly persecuting Mr. Otto Otepka, former chief of its Division of Evaluation, Mr. John R. Norpel Jr., and five others for having kept records about Communists and homosexuals in the Department as it was their duty as security officers to do.¶ This is simply proof that the State Department is now so sure of the Conspiracy's triumph that it does not hesitate brazenly to prove that it will not tolerate in responsible positions persons who are unwilling to at least co-operate with the Communists.

That same State Department now determines what equipment shall be given to our Army, Navy, and Air Force, according to admissions made before a Senate Committee by Robert (Very) Strange McNamara, who for years has been busy, under the guidance of the State Department or on his own, sabotaging our armed forces, overruling the Congress of the United States to substitute long obsolete weapons for modern ones, abolishing important military installations, and installing probable subversives among our officers. He has not yet reduced our army to a donkey-borne corps armed with slingshots, but he is obviously progressing toward that ideal with all reasonable speed. In the *Defense Department Digest* for February 1, 1965, Robert McNamara did not hesitate to say that "it would be a tremendous opportunity for us economically and socially to *eliminate defense entirely*," because that would produce a "social good." It is entirely possible that Mr. McNamara has already reduced us to a position of military inferiority to the Soviet, which is reported now to have several weapons designed and developed in the

†The reader will remember that in San Francisco the police had to raid a homosexual ball given by prominent members of the National Council of Churches and other clergymen for their boy friends. The six hundred creatures that danced with one another were all anatomically male; most of them wore lipstick and many were attired in evening gowns with artificial bosoms. Most of the ministers wore clerical garb, including trousers.

¶Strictly speaking, the State Department's charge against Mr. Otepka is that he, unlike some of his superiors, did not commit perjury to protect the traitors and degenerates in the Department. Mr. Otepka's testimony before the Senate Sub-committee on Internal Security is still unpublished—reportedly because the State Department is keeping one of its highest officials under cover and refuses to supply documents specifically requested by the Subcommittee. This is strange because observers in Washington are certain that U.S. Marshals with subpoenas and warrants could force their way into the State Department's buildings at any time, even without support from the Army.

United States but, by McNamara's edict, never produced for the use of *our* armed forces. Strange things have come to pass, haven't they?

Finance and Communism

Many of our new and more recent subscribers are no doubt surprised by our references to the connection between Finance and Communism; thus it seems worth while to provide a summary explanation of our point of view, with references to where more explanations may be found. We publish this Supplement to go in the first place to each of our subscribers, and separately to those of our readers who may find it useful in introducing new readers to our pages. The political situation is now so grave that the present task of *The Social Creditor* must be largely confined to elucidating current developments until the Communist Conspiracy is defeated and the time comes to implement a sane political economy. "Politics is the art of the possible" (Clausewitz). The defeat of Communism is possible, if sufficient public understanding of our present predicament can be achieved.

Until 1933, it was the belief, officially supported, of practically everybody that money was a commodity, largely fixed in quantity, and circulating in accordance with certain "laws" of economics. It was also believed, again with official encouragement, that money "saved" and deposited in banks, was then "loaned" by the bank, thus keeping it "in circulation". A natural corollary of this view was that money had a real commodity value, related to the actual commodity value of gold—a view sustained by the fact that in days now long past gold could be obtained on demand in exchange for other forms of currency. Bank and other currency notes were supposed to "represent" gold; and other metallic coins possessed the "value" of the metal in them.

A further consequence of this view was a belief that a country became "rich" by having a "favourable" balance of trade—i.e., exported more goods than it imported, the difference being made up by the import of money. This latter view is still generally held, and is still officially supported. It is, however, erroneous. It is impossible for every country to have a "favourable" balance; and if nations disappeared in the much advocated "One World", with whom would the unified economic system trade? Yet the necessity for a "favourable" balance of trade remains, or appears to remain, at the very heart of current economic theory.

In 1917 and in subsequent years the late C. H. Douglas demonstrated conclusively that money, apart from metallic currency, has no *intrinsic* value at all; it has an *exchange* value, which is its *purchasing power*, which is a function of the general level of prices. The origin of practically all "money" lies in the creation of credit by the banks. Banks do not lend their depositors' savings or deposits. When a customer draws on a loan (overdraft) made available by a bank, he writes a cheque which is deposited in somebody else's account at that or another bank, increasing by the amount of the cheque the total amount of bank deposits, because nobody's deposit has been reduced because of the loan. The whole process is a book-keeping transaction. Repayment of the "loan" (reduction of the overdraft), on the other hand, reduces the total of bank deposits, since nobody's account is increased by the repayment. The "money" disappears. But so long as the granting of "loans" exceeds the repayment of overdrafts, this process increases the amount of "money" in the country, and is in fact the origin of almost all the "money" in the country. But until the Socialist Revolution (*vide infra*) this process was kept concealed as far as possible, and "economists"

like (now) Sir Douglas Copland even publicly denied that it occurred at all.

Douglas also demonstrated conclusively that purchasing-power in the hands of the public was always insufficient to buy total production—a situation which gives rise to the apparent necessity to export in excess of imports. This gets rid of "surplus" production, and "imports" money to make up any remaining deficiency of purchasing-power. But Douglas's most important observation was that the production and distribution of goods was entirely dependent on the continual increase in the supply of money by the "expansion" of credit, and therefore subject to the overall policy of *financiers* who governed the policy of trading banks through the internationally linked system of Central Banks.

Douglas also showed that the whole system as it operated at that time could not go on indefinitely, and would break down. Change was inevitable, and he made proposals as to how a transition could be made to a stable system without disturbance of the economy. But as subsequent events have made plain, that was the last thing the financiers wanted. Quite the reverse.

Since practically everything a modern community does depends on the provision of finance, it is obvious that the power to provide finance by the creation of credit (on terms) is an absolutely central power, and that whatever the appearances, those in ultimate control of the banking system are the real government of a country and, on the international scale, of the world. Of course, not all those in such control are "bankers" in the sense in which one knows one's bank manager. It is in the realms of high international and national policy that the real control lies. But that power of control exercised quietly behind the facade of "inexorable economic laws", was threatened by ever-increasing production and the certain eventual break-down of the *existing* financial system. A change of such a nature as to retain power where it existed, was necessary; and although this change occurred in a crisis, it had been planned very many years before.

In 1929 the central bankers initiated a general contraction of credit—what is now known as a "credit-squeeze"—but at that time, when it was not officially admitted that the volume of money depended on the policy of the banks (the trading banks of course being dependent on the policy of the central bank), the consequences of the credit contraction—the Great Depression—were variously attributed by obliging "economists" to falls in prices, sun-spots, and other remote causes.

The Great Depression, however, was an act of high policy, designed to provide suitable psychological preparation for a major change in the economic system which would preserve and consolidate the power of those in international control of the financial system.

In March, 1933, Franklin Roosevelt was inaugurated as President of the United States of America. Very few people realised at the time that this was the beginning of a well-planned and prepared revolution. The U.S.A. had a long tradition of strictly limited government, but Roosevelt (which really means the trained revolutionary socialists around him) rapidly—in a little over three months—set up the machinery of a centralised government, exercising increasing power over the economy of the nation, and thus over the lives of its citizens. And of course at the heart of this government were—and are—the inter-

national financiers. In this way that power over policy which is resident in the provision of finance was transferred to direct power exercised through overt government—a virtual dictatorship at the centre, operating through a trained bureaucracy of socialists—socialists derived from the Fabian Society and its offshoot, the London School of Economics (endowed by the financier Sir Ernest Cassel “to train the bureaucracy which will run our future socialist state”) and parallel institutions, socialists who for decades had been infiltrated into the main institutions of society, the schools, the universities, the Churches, the mass communications media, etc. When all this had been achieved, the financial system could be altered without threat to the power of its controllers. The two main alterations were: greatly expanded, but controlled, credit for production; and enormously increased taxation, and planned inflation, to limit the possibility of enough people becoming rich enough to threaten the power of Big Government. Full Employment (to keep people out of “mischief”) and the Welfare State are components of the same scheme of regimentation of the community, all carefully planned long ago—so long ago that both World Wars and the Cold War can now be seen to be manifestations of the same Conspiracy.

Nevertheless, despite the terrible success of this Conspiracy thus far, it has not yet attained its ultimate objective of overt and impregnable World Government; to achieve this, police-state powers must be achieved in the U.S.A., as they have been in Communist Russia and Communist China, and their satellites and colonies.

This is where Communism ties in with High Financial policy and strategy. Communism is the most obvious aspect of a conspiracy to achieve World Government, openly declared. But there is only *one* Conspiracy, of which the structural components are International Finance, International Socialism (Fabianism), and International Communism.

The Communist take-over of Russia was prepared in and financed from New York, and has been sustained ever since from the same source, just as the expansion of Communism throughout the world has been and is being promoted and sustained by ‘foreign aid’, anti-colonialism, and diplomatic pressures, as in the cases of Suez, West Irian, the Congo, and the guarantee of Cuba against invasion.

In summary, then, the world political situation which exists now, and which becomes more obviously menacing almost daily, is the outcome of a long-term policy and strategy, which have over relatively long periods progressed so gradually as not to be readily perceptible but which have been able to promote and utilise major crises—World War Part One, the Great Depression, and World War Part Two—in order to effect sudden huge advances in the overall plan.

In the years since World War Part Two, the *machinery* of police-state control of the U.S.A. (and elsewhere) has been constructed and assembled. By means of a whole comprehensive series of Executive Orders for use in an unspecified “national emergency”, and by means of the Civil Rights Act, the ‘President’ (that is, the real but invisible government) can now set up a police-state in America whenever the time is ripe. Almost anything these days might constitute an emergency: but another severe contraction of credit, combined with the present international situation, could well be the detonator of the bomb which has been assembled for our destruction.

This sketch of the history leading up to this crisis before civilisation can be verified in detail from a number of now readily available and thoroughly documented books, and a list of some of them, with brief descriptions, may be had on application to K.R.P. Publications in the United Kingdom, or Tidal Publications in the Southern Hemisphere.

The basic economic considerations are definitively analysed in *The Monopoly of Credit*, by C. H. Douglas, and in *An Introduction to Social Credit*, by B. W. Monahan. A brilliant account of the socialist take-over of the U.S.A. is contained in *The Peoples’ Pottage*, by Gareth Garrett. *None Dare Call It Treason*, by John A. Stormer, is the most comprehensive and copiously documented account of all the operations of the Conspiracy, except the financial, that has yet appeared. (It has sold over five million copies.) *The Invisible Government*, by Dan Smoot, is a careful account of the reality behind the ‘President’ of the U.S.A. There are many other books bearing on the various aspects of the situation, but a careful reading of even only two or three of the books mentioned, or of others, will convince anyone who will take the necessary trouble. The end of Western Civilisation—the legacy of Greece, Rome, and Christianity—is a certainty if enough people do not take the necessary trouble to inform themselves and then others. Millions already have, but more millions are required to constitute the massive public opinion which will defeat the Conspiracy.
